Voters would not be determining exactly how many mills the new district might levy – that determination would be made by the board based on their 2025 budget.

However, Angie Hopfauf, the current manager of CASNR, said she doesn't expect they'll need to increase taxes above their current mark.

Eddy County currently levies just 6.4 mills – or approximately \$108,750 - for EMS services.

"The Community Ambulance Service of New Rockford has been very fortunate to stay well below the number of mills that could

He also served as the Wells County Farm Bureau President from 1975-76, in 1978, and from 1992-1996. From 1982-1989 he also served on the North Dakota Farm Bureau State Board of Directors.

When asked about his time with the Farm Bureau and why he became so involved with the organization, Bollingberg said he's always agreed with their philosophy, and that he always strived to help the NDFB and farmers in North Dakota adapt with the times.

"I believe that change is inevitable," he said, "and if you're going to succeed in life, you have to accept that and change or adapt as best you can, because change is going to happen either way."

N.D. in rural Wells County, Bollingberg has always had an intimate knowledge of life on the farm and what it takes to be successful.

After graduating high school he studied ag engineering at the School of Agriculture at North Dakota State University, and later graduated in 1955.

He then returned to the farm full-time, grew his family, and eventually got involved with the Farm Bureau, just like his father before him.

"I always just wanted to be my dad's son, just like he wanted to be his dad's son," said Bollingberg. And now, decades later,

his many years of service and his exceptional life are being celebrated by those he's impacted.

Bollingberg said he has so many people to thank for helping him along the way, far too many to begin naming names - but he certainly acknowledged just how blessed he's been throughout his 91 years of life.

"I'm a spiritual man," he said, "and I just believe I've been blessed over and over and over."
