Jenn Beckman, Deputy Auditor (01-23-2025) moved to approve the temporary use permit for 2025, while also stating this as an example of why the county's current request for proposal (RFP) related to hiring a company to review and update county zoning ordinances was so important to make sure these oversights did not happen again. Commissioner Casey Voigt seconded the motion.

Commission Chairman Gene Wolf expressed concern about granting a temporary use permit to a company without requiring a bond, even with previous practice of the commission, saying cleanup or maintenance of the site could come back on the county and/or landowner since the company would not have to put up any money in the form of the bond.

Commissioner Mark Pierce agreed with Wolf, saying he was concerned about setting a precedent of not requiring bonds, while Wolf added that an argument could be made over whether a temporary use permit was even needed without the bond.

"In other words, you have no stake in it if you don't have meat in it," he said, while Pierce said, "The problem is you set a precedent."

Folk replied, saying, "I have

bond was in place now. He said if the Energy Sand Solutions did not want to take out a bond, then at the least there should be a signed agreement that the company waives their right to have Mercer County be responsible for any fixes or cleanup, meaning those would fall back on the landowners and company to address among themselves.

Schwarz said he recommended the commission pursue the bond requirement, saying this is cleaner and easier to put in place.

Folk moved to amend her motion to grant Energy Sand Solutions a three-month temporary permit so the company could continue working while also meeting the necessary requirements, while still adding she did not think it was fair to punish the company for a mistake that the county had made. Schwarz said this was not a punishment but rather corrective action to make the situation right.

Voigt again seconded Folk's new motion. The motion passed 4-0, with Commissioner Rick Bauman absent from the meeting.

Prior to the Jan. 15 meeting, Schwarz reviewed the three RFPs the county received to do the work of helping reviewing and rewriting Mercer County's zoning ordinances. The commission wanted Schwarz's recommendation, but the decision was left to them; Schwarz was not present at the meeting at the time of this discussion. Voigt said he spoke with Schwarz and that both wanted to ensure the legal as well as the engineering side of this project were addressed by whichever company the project is awarded to. He recommended going with the proposal from Donovan & Kaffar PLLP and Apex Engineering for this reason. Both Pierce and Folk said

they also came intending to recommend the commission approve this company's proposal. Pierce said he liked that this proposal included a "cost not to exceed" portion that meant the companies had some skin in the game as they would not charge the county above what they quoted in their proposal, while Voigt pointed out Donovan & Kaffar and Apex Engineering were the companies that put together the county's current stormwater management ordinance, so they had experience in working on and creating ordinances in Mercer County.

Voigt moved to award the bid to Donovan & Kaffar and Apex Engineering, with Folk seconding the motion. The motion passed unanimously.

Jeff Klein with the Mercer County Fair Board spoke about the major shortfall facing the board in planning for the 2025 Mercer County Fair after the poor attendance at the 50th Anniversary Mercer County Fair last year.

Klein said the fair board applied for a stipend of \$61,000 from Mercer County but was now asking for \$150,000 from the county. He said the board needed about \$75,000 just to break even and pay the loans on the hoop barn buildings, not including the money that would actually be needed to put on a fair in 2025. Klein said the board has applied for some donations to help with the shortfall as well, but the payments were coming due in early February, so he was asking the commission to approve an increase now so those payments could be made on time. Pierce asked Klein what action the fair board was taking to address the poor turnout and money shortfall to ensure that it does not continue to be a problem. Klein said
