Dickey County Park Board Minutes

January 7, 2025 Park Board Meeting

Chair Jerry Walsh called the Park Board meeting to order at 8:03 am. Also present were Brandon Carlson, Kacey Holm, Andi Schimke, Bob Schmidt, and John Hokana. Board member Missy Lyke was in attendance via electronic means.

- Walsh turned the meeting over to the Park Board Chair Schimke.
- Additions to the agenda
- · Widening of the gate at the beach
- · Haying of County property at Pheasant Lake
- · Primitive camping

- · Brandenburger information for Wilson Dam Walsh made a motion to approve the

minutes from the October 1, 2024, meeting. Holm seconded. Motion carried.

Schimke informed the board that the new fee collection boxes at Wilson Dam have been installed

Schimke stated that all the doors at Pheasant Lake have been locked, except for one door which is broken. At Wilson Dam, two of the three doors have been locked. Keys for the third door cannot be found. Schimke priced out new locks for all the locks and the total was \$524.03. Sheriff Estes had offered to install the locks. The locks would all use the same key, eliminating the need for numerous keys. Walsh made a motion to buy the locks. Schmidt seconded. Roll call was unanimous. Motion carried. Mowing contracts for 2025 were discussed. Schimke had compile a condensed list of tasks for the person hired to mow at Pheasant Lake and Wilson Dam. Discussion followed on how it

should be advertised, as well as a cutoff date for the time frame to be mowing. Schimke fees that Pheasant Lake and Wilson Dam should be advertised together and to put in the newspaper as soon as we can. Discussion followed concerning the setting the number of times to mow or the number of hours to mow. Brandenburger stated he mowed Wilson Dam at least weekly. Advertise the position in the next month and a decision could be made at the April Park Board meeting. A decision was made to take the dock removal off the list of tasks. The timeline for mowing in the advertising would be April 15th through October 15th. Pheasant Lake

and Wilson Dam mowing area will stay

the same as 2024. The doors could be locked October 15th each year, if we are not picking up garbage.

Schmidt informed the board that the gate access at the beach needs to be widened. Schmidt stated that he will take care of it in the spring.

Schimke informed the board that she had been contacted about having the area that is not getting mowed at Pheasant Lake. The discussion followed concerning advertising the cutting of sections 2 and 3 on the map, along with the boat dock area and lot on the east side of the lake. The haying should be completed by July 1 and bales pulled within 14 days. It is approximately 15 acres of land

her conversation with Brandenburger on Wilson Dam. Brandenburger stated that the one picnic table needs to be replaced as it is dangerous to use. Bran-

denburger stated he would do put the dock in and pull it out for this year but would want to be paid \$50 to \$100 to do it. Board discussed paying him \$100 to put the dock in and \$100 to pull it out.

Board positions were discussed. Cary Wertz's position expired in 2024 and will need to be refilled. Lyke stated her residency is South Dakota and therefore can no longer serve on the board. Sheppard will advertise the two positions with the other board positions for the county. Board members would like to get more people involved in the Park Board that covers the whole county, just not the west side of the county.

Resident Cindy Bagley joined the meeting at 8:48.

The grant program with Garrison Diversion was discussed. Schimke will get the information to Administrative Assistant Amy Mittleider about picnic tables and signs for the parks

The next meeting of the Park Board is April 1st.

Holm made a motion to adjourn. Schmidt seconded. Motion carried.
