The Board of County Commissioners met in regular session on March 18, 2025, with the following present: Pine Abrahamson, Rick Braaten, Jerid Janikowski and Nathan Miller, Josh Buchmann was present via phone. Chairman Braaten called the meeting to order at 9:00 AM. The Pledge of Allegiance was recited. Guest present: Wavne Kromarek.

Braaten asked for corrections or additions to the agenda. Abrahamson moved to approve the agenda. Janikowski seconded the motion, and upon a vote, the motion was carried unanimously.

The following March 18, 2025, vouchers were approved by a motion made by Miller, with Abrahamson seconding the motion, and upon a vote, the motion was carried unanimously.

Discussion was held on approval of the Construction Engineer for Project BRP-BRJ-0006 (052), PCN 23550. Janikowski moved to approve Brosz Engineering as the Construction Engineer for the project. Abrahamson seconded the motion. A roll call vote was taken with all members voting yes. Motion carried.

Jodi Freier, Bowman County Tax Director, met to give an update on values. Tax equalization meetings will begin in April.

At 10 AM Chairman Braaten called the Unorganized Townships Annual meeting to order. Guests present: Jerry Jeffers, Wayne Kromarek, Brad Mosher, Junior McGee, Theresa McGee. The board reviewed the financial reports. Janikowski moved to adjourn the Unorganized Townships Annual meeting at 10:10 AM. Miller seconded the motion, and upon a vote, the motion was carried unanimously

Discussion was held on burn restrictions. Buchmann moved to implement the following burn restriction:

WHEREAS, Bowman County, North Dakota is experiencing conditions favorable for wildfires (drought conditions, high winds, lower humidity's, significant fuel supplies, spotty rainfall, etc.); and

WHEREAS, Bowman County, North Dakota has already experienced rural fires as of this date; and

WHEREAS, the impact of these fires could threaten health, well-being and safety of the citizens of Bowman Countv: and

WHEREAS, all available resources remain committed to protecting life and property from these fires; and

WHEREAS, the cost of response, inordinate equipment wear and fire damages may be in excess of county resources.

NOW, THEREFORE, BE IT RE-SOLVED, that the Board of the Bowman County Commissioners declare a burn restriction on open burning, fireworks, garbage piles and pits in Bowman County, effective as of this The only allowed exception to this restriction is the responsible use of gas grills, used at a safe distance from combustible materials. This restriction will be in effect when the North Dakota Rangeland Fire Index rating is in the High, Very High or Extreme category and/or a Red Flag Warning has been issued for Bowman County, North Dakota. The daily Rangeland Fire Index can be found at the following website: https://ndresponse.gov/burn-ban-restrictions-fire-danger-maps

This restriction also includes the incorporated cities in Bowman County.

ANY INDIVIDUAL WHO WILLFULLY VIOLATES THE BURN RESTRICTION IS GUILTY OF A CLASS B MISDE-MEANOR (NDCC 37-17.1-10): MAXI-MUM SENTENCES OF 30 DAYS IN JAIL AND A \$1500 FINE.

Miller seconded the motion. A roll call vote was taken with all members voting yes. Motion carried.

Frank Eberle and Jason Bullis, Bowman County Sheriff's Office, met to give an update on their office.

Teran Doerr, BCDC, met on behalf of the Bowman County Housing Authority to discuss bids received for the Jesco Apartment Siding Project.

Discussion was held on the Renaissance Zone Extension for the City of Bowman. Janikowski moved to approve a letter of support for the renewal of the Renaissance Zone. Miller seconded the motion, and upon a vote, the motion was carried unanimously.

State's Attorney Weiss reported that he is still waiting for one stockpile agreement to come back.

Bowman County Highway Superintendent, Shane Biggs, and Billy Doerr, Brosz Engineering, met to discuss road projects. Guests present: Wayne Wilson, Bo Wilson. Abrahamson moved to approve the Directional Boring Permit Applications from Slope Electric Cooperative. Janikowski seconded the motion. A roll call vote was taken with all members voting yes. Motion carried. Discussion was held on the Whiskey Road Reconstruction Project. They are still in the process of getting easements signed for the project. The bids for the project were opened on March 17, 2025. Wilson Construction is the low bid. Miller moved to grant a memorandum agreement with Fischbein-Flatz that would allow the landowner to farm within the permanent easement. Janikowski seconded the motion. Miller rescinded his motion and Janikowski rescinded his second of the motion. Janikowski moved to allow a Bowman County Commissioner to negotiate the footage of a permanent easement with a landowner regarding the Whiskey Road Reconstruction Project. Abrahamson seconded the motion. Janikowski rescinded his motion. Abrahamson rescinded his second of the motion. Buchmann moved to accommodate the requests of landowners, Fischbein-Flatz, Kelly Schumacher, and Poverty Hill Farm for their permanent easements for the Whiskey Road Reconstruction Project. Janikowski seconded the motion. A roll call vote was taken with all members voting yes. Motion carried. Janikowski moved to approve the low bid from Wilson Construction for the Whiskey Road Reconstruction Project with the condition that the signed permanent easements from Fischbein-Flatz. Kelly Schumacher. and Poverty Hill Farm are obtained. Abrahamson seconded the motion. A roll call vote was taken with all members voting yes. Motion carried. At 2:24 PM Janikowski moved to ad-

journ the meeting, with Miller seconding the motion, and upon a vote, the motion was carried unanimously.

President James called the meeting order at 4:00 pm. Motion by Shear, second by Schaaf to approve the agenda. RCV= all aye, MC.

MASON & NESS - WATER AND **SEWER DEPT.:**

Dept Head Report: Mason reported a water leak by the Krebsbach/Kulseth Funeral Home in the street. JK Excavation couldn't get here until the next day to help dig up the leak, the frost was down 4' in the ground. The funeral home and two houses were without wa-

Water Dept. Pickup: A rabbit went through the grill of the new water pickup, Mason ordered a new grill.

GARBAGE DEPT- ALLEN:

Garbage Truck Repairs: Allen stated he had a couple of garbage trucks go down during the cold spell. One truck gelled up near Baker. Another truck that had a radiator replaced twice has been leaking, he patched it and it is working for now. Westlie Truck Center employee said there is a manufacturer problem with the radiators. Hopefully they will warranty this one also.

The 2017 Freightliner has 165,000 miles on it and 10,000 hours. It has an oil leak and has an appointment at Westlie Truck Center in Dickinson, because it keeps going into D rate after they regenerate it.
