temporary purpose and to which the person returns in seasons of repose. 2. There can be only one residence.”

Another chapter in N.D. Century Code states: “A person appointed to office as provided in this chapter shall qualify within the time and in the manner required of a person elected or appointed to such office for a full term.”

The governor may remove certain officials from office “whenever it appears to the governor by a preponderance of the evidence after a hearing as provided in this chapter, that the officer has been guilty of misconduct, malfeasance, crime in office, neglect of duty in office, or of habitual substance abuse or gross incompetency,” according to N.D. Century Code.

The petition requires 50 signatures, and a sponsoring five-person committee. Devitt has 90 days to gather the signatures, and had 43 signatures as of last Saturday.

N.D. Century Code also outlines removal and appointment proceedings.

When the petition is filed, the attorney general shall conduct an investigation within 30 days. Upon completion of the investigation, the attorney general shall make a recommendation to the governor whether a removal proceeding should be conducted by a special commissioner. The governor may then

suspend the official.

When asked if the removal petition is personal, Devitt admitted it may seem that way.

“I understand that,” he says. But conversations with others prompted him to pursue this action, he says.

“Based on the pattern of behavior and the inability to acknowledge that they were wrong, and just doubling down and tripling down, in my opinion, stonewalling me at the board meetings, not even listening to what I have to say,” he says.

“You don’t have to dislike our current sheriff or the board members to sign the petition. You just have to

say, ‘They did something wrong. Let’s make it right.’ Unfortunately, they’re forcing me to do this this way, where they could have just easily said, ‘OK, we made a mistake, we’re sorry,’” Devitt says.

“I’ve lost hours and hours of sleep in this over what I thought would have been a simple fix,” Devitt says. “This is a serious violation in my opinion. ... I’m actually even kind of a little bit disheartened about the apathy of some of the people that I’ve talked to, and they’re like, ‘Who cares, it’s no big deal.’”

Dillon says he has lost sleep over the issue as well.

With only two licensed deputies and a sheriff, Dillon points to the jeopardy his removal would place on the county and department.

“Times are tough

for law enforcement in small communities across the state. There is a very large number of law enforcement job openings in the state,” he says. One new hire will start training in February.

“We are still one deputy short and we have no applicants at this time. I am a resident of Grant County according to the laws of North Dakota. I’m appointed, not an elector. I have eight years of experience and willing to serve this community as your sheriff. It would be a shame to lose my experience and not be able to fill the open deputy position,” Dillon says.
