ARMORY CUSTODIAN: Fitness Center membership money brought last month was \$2,020.00. Ms. Schalesky discussed a recall on a piece of fitness center equipment, and a repair kit will be sent out. Mayor Lindquist and Council Member Gaylord along with Ms. Schalesky completed an assessment of security camera needs. Connection Church has started using the room they rented for the next couple months, keys needed to be made so they had easier access. A quote from Computer Express for the purchase of a laptop or desktop for Ms. Schalesky's office. Two quotes were obtained for new camera system in the Armory, one from New Vision for cameras was \$10,500 and one from Computer Express was \$6,975. Council Member Parrill moved to approve the purchase of a desktop in the amount of \$1,759, second by Council Member Gaylord, and by unanimous vote; motion carried

ALAN SLATER: met with the Council to discuss the application for beer-wine, no offsale license. Mr. Slater discussed the old Carmel Cleaner building and wondered how to go about adding handicap parking to the front of the building. Suzie's LLC will be located in the building and would like to have a handicap sign up at the corner. Mr. Slater also questioned the reason the city is making Suzie's LLC remove the AC unit from the sidewalk South of the building. Mr. Slater discussed the city has benches, garbage cans, etc. along sidewalks in town. Katie Roseland discussed the topic with the reasons why the AC unit should be removed, and options the city had. The City Council would be liable for any possible injuries that having the unit there could cause. Mr. Slater discussed garbage cans, and the posts located outside the old Lyles Western Wear building, and requested the Council be fair with everyone in the community. Section Section 1: entitled "Lawn Clipping and Tree Branch Disposal Site" is hereby amended and re-enacted as follows:

Lawn Clipping and 3.020 Tree Branch Disposal Site The Hettinger City Council may from time to time designate certain sites within or around the City of Hettinger which shall be used as a designated space for citizens of the City of Hettinger may use to dispose of their lawn clippings and tree branches. Materials which may be deposit-

ed at the site include grass clippings and tree branches measuring no more than 6 inches in

The only persons allowed to use the Site are residents of the City of Hettinger, depositing materials from their own residence.

Repeal Ordinances in Conflict. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed

Section 3: Severability. In the event any section of this Ordinance is held invalid by a court of competent jurisdiction, the invalidity shall extend only to the section affected, and other sections of this Chapter shall continue in full force and effect. Section 4: Effective Date. This Ordinance shall be in full force and effect from and after final passage

SECOND READING & FI-PASSAGE-ORDINANCE AMENDMENT TO KEEPING OF CHICKENS: Mayor Linquist read the Ordinance. Council Member Ebert moved to approve the second reading and adopt as final passage of the ordinance, second by Council Member Burwick, and by unanimous vote; motion carried.

Mayor Linquist declared the approved final passage of Ordinance. The Ordinance reads as

ORDINANCE NO. 2 0 2 5 -

AN ORDINANCE AMENDING SECTION 11.0301 OF THE CITY CODE OF THE CITY OF HETTINGER, NORTH DAKO-RELATING TO KEEPING OF CHICKENS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HETTINGER, NORTH DA-KOTA, AS FOLLOWS:

Section 1: Section 11.0301 entitled "Keeping of Chickens" is hereby amended as follows:

11.0301 – Keeping of Chickens (1) Chickens permitted. It is unlawful for any person to own, control, keep, maintain or harbor chickens on any premises within the City unless issued a permit to do so as provided in this section. No permit shall be issued for the keeping or harboring of more than six (6) female chickens or hens on any premises. The keeping or harboring of male chickens or roosters is prohibited.

(2) Definitions. For the purpose this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning. "CHICKEN" means a female chicken or hen.

"AT LARGE" means a chicken out of its chicken run, off the premises or not under the custody and control of the owner. 'CHICKEN COOP" means a structure for housing chickens made of wood or other similar materials that provides shelter from the elements.

'CHICKEN RUN" means an enclosed outside yard for keeping chickens.

"PERSON" means the resident, property owner, custodian, or keeper of any chicken.

PROPOSED "PREMISES/ USE" means any platted lot or group of contiguous lots, parcels, or tracts of land and is located within the city.

(3) Permit. No person shall maintain a chicken coop and/ or chicken run unless granted a permit by the Hettinger City Council. The Hettinger City Council is authorized to issue a maximum of ten (10) permits annually for the keeping of chickens. The permit shall be subject to all the terms and conditions of this section and any additional conditions deemed necessary by the Hettinger City Council to protect the public health, safety and welfare. The necessary permit application may be obtained from the City Auditor's office. Included with the completed application must be a scaled diagram that indicates the location of any chicken coop and / or chicken run, and the approximate size and distance from the adioining structures and property lines, the number and species of chickens to be maintained at the premises, and a statement that the applicant/permittee will at all time keep the chickens in accordance with this ordinance and all the conditions prescribed by the Hettinger City Council, or modification thereof, and fail-ure to obey such conditions will constitute a violation of the provisions of this section and grounds for cancellation of the permit. The applicant shall include written consents/approval from all property owners owning real property within 300 feet of the boundary of the property listed in the permit application. If proof of written consent/approval from all affected Owners is not submitted along with the application, the applicant shall provide proof of the certified mailing to all property owners within 300 feet of the boundary of the proposed use that do not provide their consent or approval.,. Certified mailing(s) shall advise the property owner(s) the applicant is applying for a permit from the City of Hettinger for the keeping of chickens on their premises., The Certified mailing shall further notify the property owners that they may object to the applicant's permit application, provided that any objection must be received by the Hettinger City Auditor within 10 days of the mailing date of said notice and failure to provide written objections to the

Hettinger City Auditor within 10

days of the mailing of said notice will authorize the Hettinger City Council to issue a permit for the keeping of chickens to the applicant at their premises. Upon receipt of a permit application, Hettinger City Council shall determine If the application is complete and contains the reguired consents/approvals and or proof of the certified mailing of the required notices. If the application is complete and includes written consents/approval from all property owners with-in 300 feet of the boundary of the proposed use, the Hettinger City Council shall issue a permit for the keeping of chickens to the applicant. at the next City Council meeting upon receipt of the completed application, unless the Hettinger City Council receives a written objection from a property owner objecting to the applicant's application for the keeping of chickens, in which case no permit shall be issued. No permit shall be issued for an incomplete application or for the keeping of chickens on any rental premises. A permit for the keeping of chickens may be revoked or suspended by the Adams County Sheriff for any violation of this section following written notice. The applicant permittee may appeal the revocation or suspension of their permit by requesting in writing a hearing before the city council within seven (7) days of the notice of revocation or suspension. The request for hearing must be either postmarked or received in the city Auditor's Office within seven (7) days of the date of the notice. The city council shall hold a hearing on the applicant/ permittee's request for hearing within thirty (30) days of request for hearing. An annual fee will be set by resolution. Confinement. Every per-

son who owns, controls, keeps, maintains, or harbors chickens must keep them confined at al times in a chicken coop and chicken run and may not allow the chickens to run at large. Any chicken coop and chicken run shall be at least six (6) feet from any residential structure or any other structures on any adjacent

Chicken Coops and Chick-

(a) All Chicken coops and chicken runs must be located within the rear yard subject to a twenty (20) foot setback from any adjacent premises and be a least six (6) feet from any residential structure or dwelling or any other structures or dwellings on any adjacent premises. Al chicken coops must be a minimum of four (4) square feet per chicken in size. All new chicken coops must be a minimum of four (4) square feet per chicken in size, must not exceed ten (10) square feet per chicken in sizé, and must not exceed eight (8) feet in total height. Attached fenced-in chicken runs must not exceed twenty-four (24) square feet and fencing must not exceed six (6) feet in total height. Chicken runs may be enclosed with wood and/or woven wire material and may allow chickens contact with the ground. Chicken feed must be kept in metal predator proof containers. Chicken manure may be placed in yard compost piles.

(b) All new chicken coops must either be:

(i) Elevated with a clear open space of at least twenty-four (24) inches between the ground surface and framing/floor of the

coop; or, (ii) The coop floor, foundation and footings must be construct-ed using rodent resistant con-

(c) Chicken coops are not allowed to be located in any part of a home and /or attached ga-

(d) Chickens must be secured in a chicken coop from sunset to sunrise each day.

(6) Conditions and Inspections. No person who owns, controls, keeps, maintains, or harbors chickens shall permit the premises, whether the chickens are kept, to be or remain in an unhealthy, unsanitary or noxious condition or to permit the premises to be in such condition that noxious odors are carried to adjacent public or private property
