City officials want this blight removed at 407 3rd Street South in Wahpeton. Despite tenants with legal issues, the

The City of Wahpeton is still trying to get blight property cleaned up, but one resident is jailed on meth charges and the other has an active warrant out for missing a court date.

Despite these issues, the city is going to move forward to clean up the properties.

"(City Attorney) Brittany Hatting had con- Cusey is facing multacted (the property owner's) attorney, and we were going to get together and try to get a timeline for those trailers to be removed out there." Building Official Todd Johnson said during a recent public works and safety meeting. In March, Richland County Sheriff Deputies charged Terrence Lee Cusey, 73, with possession with intent to manufacture or deliver a controlled substance, namely meth

"Terrence Cusey, 407 3rd Street South; he is currently incarcerated in the jail. He's going to be constructing a new shed and tearing down the one he was ordered to tear down," Johnson said. In other action:

• The Leach Public Library is in need of interior plaster repairs.

Library Director Melissa Bakken spoke at the Public Works and Public Safety Committee on Tuesday, March 25 about the repairs.

"We've had leaks in the past up on the parapet ... The leaks have been fixed, but now we need some repair for interior plaster," Bakken said. "This year's bid was \$48,550, and that's due to the fact that the sub-contractor can do both the repairs and the paint work. The repairs are basically the east wall, the north wall and the west wall; but the entire band of the upper area of the library would have to be painted due to the fact that it's faded," Bakker said.

"The library fund balance is about one and one-half times their annual expense budget, so they definitely have cash on hand specifically for this," Finance Director Darcie Huwe said.

The library plans to start the repairs later this year in late summer or early fall.

The committee approved moving forward with the repairs and it will now go to the city council for final approval.

Wilkin County Courthouse will no longer offer drivers license renewals

Commissioners make difficult decision to discontinue services

Residents in Breckenridge will have to drive to Fergus Falls or Moorhead to renew their driver's licenses because the Wilkin County Courthouse will no longer offer

that service.

Rick Busko, vice chair of the Wilkin County Board of Commissioners, told the Daily News the county looked for other alternatives.

"Due to forthcoming unfunded mandates from the State of Minnesota and budget considerations, Wilkin County has made the difficult decision to discontinue driver's license services, for which a date has not yet been determined," Busko said in a statement.

He continued, "This decision was not made

lightly, and the commissioners looked at all options in both the governmental and private sectors, and it was deemed to not be feasible."

The commissioners understand this will be an inconvenience for their residents but feel it is the right move to keep local taxes low.

"Wilkin County Commissioners are trying to be proactive at keeping our tax levy as low as possible. Residents will still be able to access driver's license services through the Minnesota Depart-

ment of Motor Vehicles or other nearby counties," Busko said.

Busko added, "We understand the inconvenience this may cause for our residents. However, we must prioritize our resources to ensure the continued delivery of essential services to our community. We apologize for any inconvenience this may cause and appreciate your understanding as we work to manage our resources effectively."

Driver's license services will be discontin-
