TO AUTHORIZE EXCESS TAX LEVY**

Notice is hereby given that the governing body of Lidgerwood Fire District, Richland County, North Dakota has declared by resolution, that the amount of taxes which may be raised at the maximum rate authorized by Chapter 18-10 of the North Dakota Century Code is inadequate for the necessary requirements of the fire district and that it is necessary to levy taxes in excess of said limitation for the purpose of meeting current expenses. The issue of approval or rejections of a 8 mill excess levy for tax years 2025, 2026, 2027, 2028, 2029, 2030, 2031, 2032, 2033 and 2034 will be presented to the voters at a special meeting called for that purpose on April 21, 2025 at the Fire Hall at 7:30 p.m. the total amount of income for the year 2024 was \$151,833.16; the total expenditures for the year 2024 were \$92,272.11. The estimated expenditures for each of the years for which the excess levies are sought are \$99,000. The aggregate amount of the tax levy which the board seeks authority to make for each year is \$139,530. The aggregate amount of the tax levy permissible without special authority from the electors for each year is \$53,665. The amount of tax levy in excess of the statutory limit which the board seeks authority to make for each year is \$85,865. Total revenue as stated above includes revenue from all sources and not only revenue from the current year's tax levy.


