50 Years ago

Thursday June 22, 1972

• One hundred and one North Dakota high school students from all parts of the state attended a 5-week pre-vocational educational session at the North Dakota State College of Science in Wahpeton. Ronald Entzie of Lehr was in attendance.

Thursday June 8, 1972

• The Gold Star Saddle Club of Ashley put on the Point Horse Show, in June of 1972. Members of the South Central Horse Show included clubs from Strasburg, and Mobridge. The program included events such as open reigning, sack races, ladies' barrel races, 3-legged sack races, ladies' goat tying, and a ring race.

30/25 Years ago

Wednesday July 10, 1996

• Ashley promoter Bob Delzer gave the area's heavy metal fans something to bang their heads about in the summer of 1996. The band Hotter Than Hell, a band that imitates the sounds of of 1970's rockers Kiss. As well as Mr. Crowley a musician who mimics the sounds of Ozzy Osbourne.
