(Continued from Page 1) ment or possibly just finding a new job in general," she

Another concern is what happens if a state's attorney investigating a complaint about a library deems a violation took place.

In that scenario, the library or school district will have 10 days to comply with state law. If they fail to do so, then their funding can be withheld, either by the state treasurer's office or by the Department of Public Instruction, respectively.

Lund said the Divide County Public Library receives about \$8,000 to \$10,000 in funding from the state each year.

"Maybe up to \$12,000 sometimes," she said. "That is the funding that would be cut."

There would also be costs to buy or build a case or cabinet to house any books that are deemed sexually explicit.

Along with withholding funds, the local state's attorney could also prosecute the library or school district if they don't comply.

Lund said even just having a book deemed sexually explicit sitting on the counter and waiting to be shelved could go against the bill.

"I have a gal from the high school that comes down and helps me in the afternoon," she said. "If she is still 17 and she sees that, then according to the bill, I am displaying it, and then I can be prosecuted," she said.

Beyond the challenges that could come with trying to comply with the new bill, Lund also said trying to prevent minors from reading about any uncomfortable or difficult topics could be a detriment to them in the future.

She used an example of recently talking to her daughter about a book that included mentions of suicide.

"I think, in today's world, that we're trying to shield so many kids from things," she said. "Well what's going to happen when they get out of Crosby, when they go to college? I just don't think we're giving them everything that they need to be successful."

Several organizations in the state, including the North Dakota Library Association and some state's attorney offices, have been sending letters to Armstrong urging him to veto the bill.

Lund also encouraged people who oppose the bill to reach out to the governor, as

"Sending a letter to the governor's office, emailing the governor," she said. "I still think it's important to let our legislators know if they are disappointed."

She also said community members are always welcome to bring any concerns they have to either her or the library board.

"I truly do sympathize with those who feel this bill is necessary. But for families with concerns, we already offer so many options," she said. "They're always welcome to visit the library, view our collection or even monitor their child's checkouts online. We have policies in place that support parental involvement and transparency."
