Mr. Pedersen went over all the different activities happening in elementary school, finalizing testing and field trips coming up in the last 4 weeks of school. Mrs. Donnelly has been named "Williams County

Teacher of the Year" for 2025 by the NDDPI. Grades 5 & 6 will have their Spring Music Concert on May 6th at 6:30 pm. A Title I parent meeting will take place prior to the concert at 6:00 pm in the library. It is Staff Appreciation Week May 5th- 9th. Mr. Pedersen thanked the board for all their support during his first year here in Ray and is looking forward to next year.

Mr. Heier reported the MTSS 3rd round of screening will take place the first week in May. NDA+ make-up testing will take place next week. Mrs. Vejtasa is working with high school classes on their 4 year rolling plans and pre-registration for next year. The sophomores completed the Pre-ACT on April 1st. The Scrubs Camp went well for the 7th graders on April 2nd. The HS Student Appreciation Banquet will be held Wednesday, April 30, 2025, at 6:30 pm. Supper will be served from 5:45 pm-6:30 pm that night. The JH Student Appreciation Assembly will be Thursday, May 15th at 2:15 pm. Graduation is Sunday, May 18, 2025, at 4:00 p.m.

Mr. Kuehn reported that prior to the meeting the Governor vetoed HB 1540. ND legislatures are trying to wrap up the session this week. Mr. Kuehn is starting to prepare for the Cognia Accreditation Review for January/February 2026. He will be sending out parent and community surveys in preparation for the review. The Federal Funds Monitoring is complete. He reviewed the oil revenue compared to last year with the board. May 6, 2025 is the school board election.

West Side Annexation- the annexation process is waiting for survey to be completed on the Solberg property subdivision. IEI will work with the city auditor to schedule a meeting to go over the next steps, tentatively at the end of April.

Solberg Properties- The final plat of the proposed subdivision was approved at the Planning and Zoning Commission Meeting and at the regular City Commission Meeting, both on 3/12. IEI is working with Williams County for their review and will then move on to signatures from Solberg's and City.

Pitt Group Lot Rearrangement-Recordation of the lot line adjustment may not occur until the proposed development is recorded, which can be done at the same time. IEI, the property owner, and the City's attorney have finalized the development agreement. IEI is working with Pitt

Group on signatures. The plat had a change where the proposed utility was going to be, so the easement changed. We don't have the actual final plat, recommend a motion to approve at the next meeting.

Parks Planning - City Commission approved the park concept for the Prairie Heights pocket park at the Special Meeting on 4/3. IEI funding staff are exploring funding opportunities to present to the City Auditor.

North Dakota Department of Transportation –IEI is reviewing submittals and RFI's Construction will begin in April 2025.

2025 Chip Seal project- 9,916 lineal feet, Chip Seal project. The project was bid on March 13th and awarded to Astech on April 3rd in the amount of \$149,881.90. IEI is currently waiting for contract documents.

South Park Road - Street Committee met on August 29, 2024. South Park Road paving project is estimated at \$1.8 million including legal survey. NDDOT currently has a Special Road Fund program for roads that provide access to recreational, tourist, and historical areas. Funding requires a 40% match with a cap of \$300,000. Application was submitted on November 27, 2024. Notification has been received from the NDDOT that the City of Ray has been selected for the funding of this project. See attached award letter.

Barman moved to notify the NDDOT that the city wishes to accept the SRF funding, and to have IEI prepare a task order for the South Park Road project. Seconded by Brunner, RCV MCU.

IEI will arrange to meet with the City Attorney for discussion of legal survey requirements prior to start of any legal survey efforts. See attached South Park Road Exhibit.

Water Main Extension Project IEI submitted plans and specifications to NDDEQ. Project is out to bid with a bid opening on April 24th. The contract cannot be awarded prior to all permanent easements being signed. Construction cannot begin prior to all temporary construction easements being signed. IEI has submitted a draft utility crossing permit application to NDDOT for the proposed Highway 2 water main crossing and received comments. A final permit application will be submitted after award of the contract. Lead Service Line Inventory

(LSLI)- IEI has received a signed Task Order from the NDDEQ for Category B (Phase II) - Onsite Validation of Records Review for the Lead Service Line Inventory (LSLI). This phase will focus on identifying the material of unknown service lines. The process includes three (3) attempts, with the first being a second round of customer identification surveys, which will include a letter explaining the purpose of this project, followed by two (2) door-to-door attempts to directly access service lines with unknown material that did not respond to the survey. IEI anticipates sending out the customer identification survey letters to those with an unknown status the week of April 14th and will work with city staff during the door-to-door attempts. IEI encourages city staff and the residents of Ray to participate in these attempts by completing the survey and to cooperate with the door-to-door team when they visit. This information is essential for the city's infrastructure planning and future safety measures

Sanitary Sewer CIPP Rehabilitation Project - Project is out to bid

with a bid opening on April 24th. Funding Opportunities- BND IRLF and CWSRF loan applications have not been submitted. Brunner moved to Apply for the BND loan only. The BND loan does not require

a facility plan and does not include AIS/DB requirements. The water portion will be paid with the loan. The sewer portion will be paid with city funds. Seconded by Barman, RCV MCU

Approximately 90% of the topographical drone survey has been done; I have asked IEI to schedule and complete the drone survey. To look at the potential footprint of this property. Barman stated the three major nuisance properties have been contacted again this spring, one residential will be fined soon, the other residential Barman is waiting to hear back from them. The commercial property is having a meeting this Thursday and will call with updates and plans or if property will be listed for sale.

Jeff Schneeman started April 8th and will be on a six-month probation.

Storm drain on corner of First Ave & Main St, does not catch sunlight so is still frozen when melting begins. Public Works rented a heater and had down drain, with very little effect. They then used a steamer, which opened drain in about 30 minutes. Liesener moved to have Public

Works purchase a steamer for approximately \$1,600.00. Seconded by Nelson, RCV MCU. Approve the \$150.00 gift card to

with commission, noting 4 blocks of crack seal overlaps w/chip seal project. B's will have those 4 blocks done before chip seal.

Nelson moved to approve the crack seal proposal for 37 blocks, in the amount of \$85,615.00. Seconded by Barman, RCV MCU. NDSU Community Forestry Spe-

cialist, Joel Allen and Forest Steward Specialist, Emily Hoyt visited Ray and accessed tree rows, tree species and discussed forestry options for the city. Providing guidance on windbreak renovations and wildfire mitigation.

Their recommendations are:

• At a minimum, removal of dead and dying trees on City property. They feel 98% of the two north trees rows are dead- spring will reveal

 Keep tree rows clean of all dead and dry debris.

 Consider adding boulevard trees rather than windbreaks to the new developments north of town. Windbreaks are appropriate for rural properties or along natural areas in cities, but they could create future problems for clearance, line of sight, and wildfire fuels if planted in the middle of a residential neighborhood.

• Emerald ash borer (EAB) is an exotic insect pest that poses a threat to a large amount of Ray's community forest. Preemptive removal of poor condition ash and replanting a diversity of other species can help offset the impact EAB will have on vour town.

We also have hay bales right outside of city limits- the foresters and Williams County Emergency Management noted as a fire hazardhaving a large fuel load in windy conditions. Liesener asks if we should consider a stripper stubble ordinance within a certain radius of city limits; within our ETJ?

Kupper appoints Liesener and Barman to a committee to correspond with attorney for recommendations on this matter.

We are waiting for a bid from a tree removal contractor and awaiting recommendations for planting back trees/shrubs- hoping to work with the county. Recommendation for a heartier tree ordinance. We are also looking at grants to assist the city with associated costs and/or grants to assist citizens with tree replacement on private property.

Barman moved to allow Schmidtgal and Rustad to proceed with recommendations from NDSU Forestry Specialist and Forest Steward Specialist regarding removal and planting of trees. Seconded by Brunner, RCV MCU.

Brunner moved to adjourn, seconded by Nelson, RCV MCU. Meeting adjourned at 8:17 p.m..
