# CITY: Public engagement is stressed

(Continued from Page 1) in," he said. "Everyone understands the decisions that were made and how we got there."

Feil and Klabunde also discussed how Moore could potentially address Crosby's water and sewer infrastructure and the Hendrickson-Holmes project.

"We acknowledge that there has been a lot of divisiveness in the town," Feil said. "I've heard some very different perspectives about the events that have led up to today.'

The council voted to cancel the \$13.8 million project in July last year, largely because of the cost to the city and the potential tax increases it would bring to residents.

Feil gave a few different options of how Moore could go about water main replacements if necessary, including open cutting, boring or pipe bursting.

They also discussed sewer rehabilitation and provided an example of a cured-in-place lining they can do for damaged sewer pipes.

"It's a very cost-effective way to rehabilitate sanitary sewer mains," Klabunde said.

Road repair and crack sealing were also among Moore's possible services.

Feil and Klabunde also stressed the importance of planning ahead for road repairs and how to fund them, as waiting too long to fix certain cracking can further deteriorate the roads and add to future costs.

"So understanding how things go in cycles, having a capital improvement plan, applying for funding early so you're planning for things ... is really critical," Klabunde said.

Feil also talked about the importance of getting public engagement for any projects the city decides to pursue in the future.

"Getting the community active in the decision-making for the things that are going to impact them," he said.

He added those discussions can include local "stakeholders" like organizations or businesses, and the approach that Moore uses to field those responses can vary depending on what the council wants, as well, like using public meetings, surveys, focus groups, etc.

"The goal for public engagement is to build transparency," Feil said. "We want to foster an understanding between you and me, between us and the public, of what the need for the project is."

Another part of their engagement plan would be meeting with each council member to learn about their concerns about city infrastructure and expectations for the city's engineering firm.

"That way we can work together, and us as your trusted adviser guiding you toward the right goals that you want to have and how to accomplish those goals for your community," Feil said.

Council members had the opportunity to ask Feil and

Klabunde questions at the end of their presentation.

Council member Doug Anderson wondered how adding Crosby to Feil's workload of other city clients may impact his ability to travel to Crosby.

"If I get to work in Crosby, you'd be my sole city that I'd be going to council meetings for," Feil said.

Anderson also asked how Moore would specifically address Crosby's aging infrastructure and determining what areas of town should be focused on first.

Klabunde said the firm has a web-based software that can help determine areas in town that are most in need of repairs.

"If it's street maintenance, it could be breaking the town into quarters; if it's infrastructure, ranking and prioritizing the need based on age and condition is a part of it," he said. "You're going to rely on us to help you rank those things based on need, and hopefully there's some trust that goes along there."

Following the presentation, council members scored Moore and the other engineering firms that presented on several different categories, including the qualifications of firm personnel, their understanding of city engineering services for small communities, knowledge of the city's infrastructure and more.

Moore Engineering received 320 of 400 possible points from the scoring.

Artman said his dad mowed lawns and was a professional landscaper before the family moved to Crosby, with that interest eventually rubbing off on him.

"I bought my first lawn mower for like \$4,000 from Gjovigs when they still owned the hardware store," he said, "and then I would just go mow around town with that.

Artman started his business in a more official capacity about two years ago.

"Didn't do much las I worked on a ranch," he said. "This year we're trying to get as much work as possible around town and even in surrounding areas."

Along with mowing, some of his other services include aerating and dethatching lawns, hedge trimming, replacing or removing rock or mulch beds, tilling gardens

"It can be a lot more than just mowing your yard down with a mower," Artman said.

He also gets help from his younger brother Cole and Adam Knudson, another former Divide County student, as well as a few other friends of

"I usually never mow alone," he said. "I always find someone.'

Artman also mentioned

how finishing his high school education online allowed him to dedicate more time to his business, saying his schedule is now more flexible.

"At the start of the season when you're really busy, like right now, I would be in school for seven hours a day, and on top of that have homework,' he said. "It's kind of weird because I'm a lot more busy being outside of school, but it's a lot less stressful.'

For the short term, Artman plans to see how well the lawn care business does this summer and whether it could become something he does more permanently, possibly even expanding his services.

"This season is a big teller if I can sustain it or if I want to move into winter services," he said.

Otherwise, one of his other ideas is trying to start a business in another state.

"There's Alaska, which I know a guy moving to possibly," he said. "I'll start a business up there; if he does that, I'll go with him. There's also North Carolina where my brother and his wife and their soon-to-be kid live."

In either case, he added he would like to settle down in Divide County eventually.

"I call Crosby my hometown," he said. "I love Crosby to death."
