# **SPORTS** Huskies going to state!

The Hettinger County Huskies track and field team will send 10 athletes to the state meet following qualifications at the Southwest Region Meet in Dickinson May 17. The top three or those with qualifying standards qualify for the state meet in the regional competition.

Among the boys, junior Mark Fitterer qualified in the 100-meter hurdles with a personal record (PR) of 17.10 seconds and a second-place finish. Sophomore Mike Greff qualified in the javelin with a throw of 136'10" for a third-place finish, and freshman Will Grist leaped 40'3.5" for a PR and a third-place finish in the triple jump.

Among the girls, eighth-grader Shaunie Mayer qualified in the triple jump with a PR of 34'7" and a second-place finish.

The girls also qualified with three relay teams.

The 4x100 relay team of seventh-grader Brystol Belland, junior Kallie Dinius, junior Carly Wolf and eighthgrader Teagen Penn took third to qualify. With a qualifying time and taking fourth place, the 4x200 relay team of sophomore Kara Roll, Dinius, Wolf and sophomore Meadow Olsonawski qualified for the state meet. Those same four also logged a qualifying time as the 4x400 relay team.

"We had a great day," Coach Ron Benson said. "It's been a great attitude all year. These kids have been lights out. They've been fun and they've been working hard. They come to run and it's just amazing.'

"Those girls ran their best performance all year and that's what you want at the end of the year," Benson said. "They had good preparation. They had the right mindset and they went after it."

The relay teams were able to practice on the new track in New England, which was a benefit, Benson said. "To get on that surface and do quick workouts and do handoffs over there, it really is quite a facility and that is very helpful," he said. With a young group of athletes qualifying, Benson is positive about next year's prospects as well. "There's a lot of good talent coming up," he said. The 2025 combined Class A and B track and field state meet will be held May 22-24 at the MDU Resources Community Bowl in
