Dickey County Commissioners Meeting, April 15, 2025

Commissioners Meeting April 15, 2025

hair Brandon Carlson called the meeting to order at 9:50 am. Commissioners John Hokana, Jerry Walsh, Kacey Holm, and Marke Roberts were also present. Auditor Sheppard, JETx representative Kris Koch and Applied Digital representative Martin Vega were also present. The media was not present. The Pledge of Allegiance was recited. Dickey County Sheriff's Office, Recorder Kelly Schmidt, States Attorney Kim Radermacher, Deputy Clerk of Court Cresta Miller, Deputy Recorder Lori Wald, and Administrative Assistant Amy Mittleider joined the meeting via electronic means.

minutes of the April 1st meeting with corrections. Roberts seconded. Motion carried.

Roberts made a motion to approve the vouchers as submitted. Holm seconded. Roll call was unanimous. Motion carried. Hokana made a motion to approve the

March financial statement. Walsh sec-

onded. Motion carried. Valley Township Clerk/Treasurer Dale Radermacher joined the meeting at

Walsh gave an update on the Human Services Zone meeting he attended. Medicaid numbers have declined. The call center is experiencing a high turn-

over in staff, due to the nature of the job. Tax Director Don Flaherty and Treasurer Wonada Lematta joined the meet-

ing at 10:13. Flaherty discussed with the Commission possibly missing a township equalization meeting or two. Flaherty is requesting that Ellendale City Auditor Nicole Kempf, who is a certified assessor, be responsible for any meetings Flaherty may miss, as Deputy Tax Director Kasie Kinzler is not certified at this time. Walsh made a motion to pay Kempf \$150 for each meeting that requires her attendance plus any cost of travel. Holm seconded. Roll call was unanimous. Motion carried.

Holm made a motion to open the abatement hearing. Roberts seconded.

Flaherty presented four parcels with late homestead credit filings. Three of the four parcels include tax year 2023 and 2024. The fourth parcel is for tax year 2024. One parcel has 50% credit for 2023 with an increase to 100% for 2024 tax year. One parcel is 50% credit for both tax years. All the other parcels are 100% for the tax years filed. All applicants fit the guidelines of homestead

Walsh made a motion to approve the abatements as presented. Holm seconded. Roll call was unanimous. Motion

Flaherty informed the Commission about two corrections that need to be recalculated on two parcels. The first will be a refund and the second one will need a portion paid back to the county. Due to the issue was a county error, Flaherty is requesting that the discount received on the incorrect number be honored for the second payment if the payment is received in the next 30 days. Roberts made a motion to approve granting the discount, if payment is received within 30 days. Holm seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to close the abatement hearing. Holm seconded. Motion carried.

Flaherty requested the Commission allow Flaherty to contract with Vanguard Appraisal for assessing the new buildings at Applied Digital. Flaherty stated the cost would be approximately \$215 per hour, with a cap of \$12,000. Walsh made a motion to authorize Flaherty to contract with Vanguard Appraisal for the appraisal on the new buildings at Applied Digital. Hokana seconded. Roll call was

unanimous. Motion carried. Holm and Carlson updated the Commission on the land auction with a gravel pit in Dickey County. The price agreed upon during the executive session was not high enough and the auctioneer would not split the offer. Discussion continued concerning possible changes to the auction. Radermacher advised that the Commission should enter in executive session to discuss matters if something were to change.

Sheppard informed the Commission that the air conditioning unit in the Auditor's office vault appears to have died. The server in the vault needs to be kept cool. Sheppard is requesting authorization to purchase a new A/C unit, if needed. Holm made a motion to authorize Sheppard to purchase a new a/c unit, if needed. Roberts seconded. Roll call was unanimous. Motion carried.

Discussion followed concerning the combining of the Auditor and Treasurer position that Walsh presented at the March 4th Commission meeting. Also discussed was the plan Roberts presented at the March 18th meeting of changing the Auditor, Treasurer, and Recorder position to appointed and the hiring of a County Manager that would also handle human resource issues. The cost of a Human Resource person was discussed. Walsh stated that a Human Resource person could be appointed with the retirement of either the Auditor or Treasurer. Roberts stated that adding more tasks to one person is not the answer in his opinion. The terms of the current Auditor and Treasurer do not end until 2027. Radermacher stated that to make the changes proposed by Roberts, there would need to be a change in the form of government for Dickey County. No decision was made.

Sheppard presented the software support/license renewal agreement with Software Innovations. Sheppard stated that Software Innovations is under new ownership. Walsh made a motion to sign the agreement. Holm seconded. Roll call was unanimous. Motion carried.

Applied Digital Representative Andrea Mireles joined the meeting via electronic means at 10:50. Water Board members John Quandt and Steve Hanson, Young Township supervisor Jason Hildenbrand, Highway Superintendent Jeff Hagen, KLJ engineer Bryan Tykwinski, and Sheriff Chris Estes joined the meeting at

Radermacher submitted the proposed "Consent for Utility Company to cross a public road or section road" form. Radermacher stated it is a more comprehensive agreement and combines overhead crossings and boring crossings to one form. Radermacher has conferred with Tykwinski and the ND DOT on the form. Radermacher stated it is consistent with other counties. The current fee is \$200. Walsh made a motion to adopt the new consent form for road crossings with a \$200 fee. Hokana seconded. Motion carried. Hagen will have IT Consultant Nelson update the web site.

Hildenbrand informed the Commission the need to replace a culvert at 82nd Street and 89th Avenue between sections 24 and 25. The landowner has paid for the hydrology study. Hansen had informed Hildenbrand about the cost share program with the Water Board and Dickey County, which is a sharing of the cost evenly between the township, countv. and the Water Board. Hildenbrand is requesting this funding. Hokana made a motion to approve the use of funds to replace the culvert in Young Township. Roberts seconded. Roll call was unanimous. Motion carried. Water board will discuss the project at tomorrow's meeting. Hildenbrand will get the bill to Sheppard when the project is complete.

Roberts made a motion to open the propane bid hearing. Holm seconded. Motion carried.

Three bids were received as listed be-

Agtegra Coop \$1.499/gallon \$1.30/gallon Economy Propane

Farmers Union Oil Co \$1.24/gallon Holm made a motion to accept the \$1.24/gallon bid from Farmers Union. Hokana seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to close the propane bid hearing. Holm seconded.

Sheppard presented the easement for the Divide Township project that Tvkwinski had given her. Tykwinski stated it is a permanent easement and a temporary easement that need to be filed with the Recorders Office. Holm made a motion to sign the easements. Roberts seconded. Roll call was unanimous. Motion

Tykwinski informed the Commission that Dickey County 3C and the road to the winery were both denied for the safety program. Tykwinski stated that the best funding for County Road 3C is the flexible funding available through the state or federal aid funding. Discussion included having the highway staff place more gravel on the road and put chloride

on it. Hagen stated he would look at that. Tykwinski discussed with the Commission old easements on the north two miles of County Road #12. Most easements have been found, but have not located those for the north two miles. Tykwinski will send the list to the Recorder and the Auditor to see if anything else can be found. Tykwinski also reminded

them of the bid opening on April 21st at the Highway Shop at 11:00 am.

Hagen presented a utility permit from DRN to bury fiber optic cable along Highway #1 in sections 17 and 20 in Divide Township. Roberts made a motion to approve the permit. Holm seconded. Mo-

Hagen presented two agreements for township blading for 2025. The agreements are with Valley and Lorraine townships. Holm made a motion to have the Chair sign the agreements. Walsh seconded. Motion carried.

The meeting went into recess from 11:40 to 11:45

Applied Digital representatives Nick Phillips and Janelle Combs joined the meeting at 11:45. Phillips discussed with the Commission the passage of house bill 1444 and the effect of the bill on the actions to be taken on 87th Avenue in Ellendale Township. Phillips stated there were some things that still need to be worked through. Discussion followed concerning having a joint powers agreement with the city of Ellendale for the first mile of 87th Avenue. Applied Digital is requesting the county continue one more mile through Ellendale Township to the Elden Township line at 96th Street. Elden Township has verbally stated they would agree to have the county take over 87th Avenue to 95th Street and the two miles of 95th Street to Highway 281. Phillips stated that ND DOT has agreed to pay 50% of the cost to pave these roads. Applied Digital would agree to pay the loan payment through a special assessment to pay the balance of the total cost. Phil-

lips stated they are hoping that the project can be completed in two phases. Phase 1 would be the portion in Elden Township, as they have agreed to allow the county take over that section of road. One thing that will need to be considered is who is responsible for the maintenance of the road. Discussion included adding the road to allow the county to get federal funds in the future. Contingent on Elden Township turning over to the county the roads discussed and the approval of States Attorney Radermacher on all paperwork, Walsh made a motion to authorize Dickey County to take steps necessary to take over the roads in Elden Township (Phase 1) with the development of a joint powers' agreement with Elden Township for the first two miles on 95th Street from Highway 281 west and one mile south on 87th Avenue. Holm seconded. Roll call was Roberts ves: Carlson ves; Holm no; Hokana yes; Walsh yes. Motion carried.

Based on the framework of HB 1444 which is effective August 1, 2025, Walsh made a motion for the county to work with the city of Ellendale and Ellendale Township to take steps necessary the development of a joint powers' agreement with the City of Ellendale and the takeover of land in Ellendale Township. Holm seconded. Roll call was Walsh yes; Hokana yes; Holm yes; Carlson yes; Roberts no. Motion carried. Combs agreed to start the process and forward

to Radermacher for her review. Sheppard presented a request from the city of Ellendale for support on a grant for the purchase of a new police car. Roberts made a motion to sign the support letter. Walsh seconded. Motoin carried.

Estes informed the Commission of a possible candidate for a deputy sheriff who decided to not interview because of the lack of housing in the area. Estes will be applying for the highway safety grant, as well.

Estes discussed with the Commission on the new building and the need for an impound lot. Based on the placement of water after the last snow, more material will be need to be added if the lot would be placed on the east side of the building. Estes feels the north side would work better. Discussion included the motion made earlier to have Estes investigate putting an outside fencing area and the cost. Discussion went on to discuss the large door and the door opener that is not installed. Sheppard stated that it has been paid for. Hagen and Estes stated

they would get that installed. Hokana made a motion to adjourn at
