been raising funds and working hard to restore the 1908 Ellendale Opera House. Since that time, O.P.E.R.A. has installed a new roof, rebuilt the back wall, added ADA access and renovated a section of the Main Street store fronts into a lobby and gallery space for theater performances, art exhibits and other programs.

Sen. Erbele, Rep. Brandenburg and Rep. Grueneich were able to secure \$250,000 in N.D. Commerce Dept. funds to help with the extensive renovation work that remains.

The Opera House is a benefit both to Ellendale and to the surrounding area, and the District 28 Team believes the funds are an investment in the future.



#### Road and Bridge Funding

HB 1235, which was introduced by Rep. Grueneich and co-sponsored by Rep. Brandenburg and Sen. Erbele, has been signed into law by Gov. Kelly Armstrong. It passed the House 89-3 and the Senate 47-0.

The new law empowers the Commissioner of Agriculture, in consultation with the N.D. Department of Transportation, to award grants to cities with a population of 1,500 or less for road and bridge improvements necessary to accommodate value-added ag businesses.

Counties and township are also eligible for the Agriculture Infrastructure Grant

Program. Grueneich, Brandenburg and Erbele said the program will be a boost to District 28 communities where new ag businesses are being developed or expanded. In addition, Rep. Brandenburg and Sen. Erbele were both assigned to the conference committee that worked on the Department of Transportation's budget. They were able to negotiate dedicating a portion of the Legacy funds earnings to the DOT, and also arrange the funding streams of the Prairie Dog buckets which allow road money to flow to the townships, counties, and cities in a more timely manner and with more certainty than previous budget allocations.

### **Marion Flood Control Project**

The District 28 team also worked with the Adjutant General to secure an additional \$200,000 dollars from the Disaster Relief Fund to support the city of Marion in their flood control project.

These are matching funds that will help with some of the increase costs that have occurred since the project began several years ago.

#### Legal Drain 11

Reps. Brandenburg and Grueneich, and Sen. Erbele along with people from Sargent County put forth a lot of effort to win passage of HB 1280 and Gov. Armstrong's signature. The law will now allow the Sargent County Water Board to hold an election to resolve Legal Drain 11 issues without the involvement of Ransom County, which does not pay assessments to maintain or improve the drain. The law also creates a process to resolve landowner disputes.

# Ellendale gets more exposure

The KFYR piece noted that Applied Digital is unlikely to interfere with the area's power supply, as Ellendale is a hub for massive amounts of wind-powered electricity, far more than could possibly be used otherwise.

Phillips noted that North Dakota's Public Service Commission has authorized Applied Digital to eventually use as much as 530 megawatts of power. This, he said, is about five times the normal power consumption of Bismarck. The data center campus is projected to complete three AI processing buildings in addition to its blockchain facility, giving it a total of 2.2 million square feet of space. In short, it's a massive project, and is less than half complete at present.

Mayor Flaherty's comments echoed Jeannette Robb's optimistic outlook. "I think that this will guarantee that Ellendale will be a thriving community well into the 22nd century," he said. "This is a once-in-a-lifetime opportunity for a small town. If we want this to work, we have to be active participants in it, just like they want to be active participants in it. That means we need to work together to build a stronger community."

For those wanting more detail than was provided on the brief TV segment on KFYR, Tim Flakoll's interview with Nick Phillips provides a good depth of information. Flakoll is a Forbes native and Fargo resident whose many prominent leadership positions include periodically guest hosting the Jay Thomas show on WDAY radio. Tim recently reached out to the *Leader* for contact information from Applied Digital, and a few days later set up the interview with Nick.

In the interview, Nick provided a more thorough explanation of Ellendale's advantages for locating a data center, and discussed some of the unique characteristics of the facility currently nearing completion, which has the designation ELN02. Nick stressed, as did the KFYR piece, that the building uses closed-loop, recirculating cooling and thus its water needs are minimal. He addressed the noise issue, acknowledging that it has been an irritant to neighbors, but the company has worked hard on noise abatement. Nick's comments echoed Applied Digital's official published statements that the firm is committed to environmentally conscious operation, and strives to respond proactively to the potential negative impacts on the town and rural

While it must be noted that the interests of tech investors may not always overlap with those of established residents, the prevailing attitude seems to be that the data center campus presents a win-win situation.

Jeanette Robb seems to have captured this attitude with a brief comment, which made it into KFYR-TV's final edit: "There's going to be negative things," she said. "There always are with any growth or expansion. But it's going to put Ellendale on the map, big time, and there's nothing wrong with that."
