#### PROCEEDINGS OF THE FOSTER COUNTY BOARD OF **COMMISSIONERS AUGUST 5, 2025**

At 3:30pm, Madam Chair Hagel called the Foster County Commission meeting to order. Roll call included Commissioner Paul Roller, Commissioner David Utke, Becky Hagel. Commissioner Alan Scanson and Commissioner Pat Copenhaver. Also present was Foster County State's Attorney Kara Brinster, Auditor/Treasurer Ellen Roundy, Road Superintendent Nate Monson, and Foster County Independent Reporter Nathan Price.

The meeting began with approval of the minutes for the July Commissioner Meeting. Commissioner Roller motioned to approve the minutes, seconded by Commissioner Scanson. All voted aye and the motion passed.

Commissioner Scanson motioned to approve the bills seconded by Commissioner Copenhaver. All voted aye and the motion

Commissioner Utke motioned to approve the agenda, seconded by Commissioner Scanson. All voted aye and the motion passed. Old Business

There was no update on the lots by Juanita Lake. Commissioner Scanson noted that Dennis Swanson has been doing an outstanding job at Juanita Lake for the County. The beach has been cleaned up among many other items and he deserves recognition. The BOCC requested that Auditor/Treasurer Roundy reach out to Jamie Nelson with Computer Express for IT options in the community room now that the tables have arrived and been

arranged.

New Business Nate Monson, Road Superintendent, provided an update on the department. Out of the last fifteen days the county has seen rain for nine of them. Commissioner Utke provided a data sheet for durapatching in 2025. Discussion was had on the bridge project and flex funding project. The BOCC will need to decide their match amount for the Flex Funding application by the next meeting. CPKC has provided the BOCC with a response to their \$2.7 million request. CPKC still believes \$225,000 is adequate payment to the county for damages. Commissioner Utke would like the BOCC to have a special meeting regarding the issue. The BOCC has set a special meeting for Wednesday, August 13th at 8:00 AM at the Foster County

Auditor/Treasurer Ellen Roundy asked the BOCC if they would be OK with switching with Emmons County and hosting the next Six-County Meeting. The consensus was that it was good with the board, and they would like to have Roundy reach out to the Chieftain for the meeting location and meal. Roundy presented the preliminary 2025 budget to the BOCC for approval. The valuation for Foster County is \$35,152,488 which is an increase from 2024's valuation of \$32,500,075. HB1176 allows a three-percent increase from the previous year budgeted dollar amount. The calculation can be figured from the base year calculation which includes the last three-year levy dollar amount or an adjusted year calculation which considers properties added to the tax year and removed from the tax year. For Foster County, the adjusted year calculation provided some additional funding beyond the base year calculation. The general fund levy is currently set at \$987,317.97 compared to last year's dollar amount of \$959,567.76. Roundy presented the combined county funds preliminary budget at \$3,035,828. Commissioner Copenhaver motioned to approve the preliminary budget at \$3,035,828, seconded by Commissioner Scanson. All voted aye and the motion passed. Roundy provided an update that the county should be receiving funding from the state for the replacement of culverts from back in 2022. Michael Rivinius, Wold Engineering, has been working on getting the reimbursement since

Karen Evans presented three abatements to the BOCC. Chaz Bauer and Taylor Sabinash for \$182.19, Leo and Julie Laube for \$660.44 and two for Bobbie Joe Theis for \$50.91 and \$46.37. Commissioner Copenhaver motioned to approve all abatements seconded by Commissioner Scanson. All voted aye and the motion passed.

Commissioner discussion included closing of the section lines from the public hearing held on August 5th, 2025, at 3:00 PM. Commissioner Utke felt he received clarification on the public benefit portion requirement. Foster County State's Attorney Kara Brinster noted that it is not as unique as Lee Wahlund, however, there are special circumstances that surround this situation and the Township also signed off on approving the closure. Roundy presented the following resolution

WHEREAS, the petition was duly and properly submitted to the Foster County Board of County Commissioners pursuant to N.D.C.C. § 24-07-03; and

WHEREAS, the Foster County Board of County Commissioners having published a Notice of Public Hearing in accordance with law, and a public hearing having been held on August 5th, 2025, according to the published notice of public hearing, and having considered the petition and any support and opposition thereto;

WHEREAS, the Foster County Board of County Commissioners, after having held a public hearing on the matter, makes the following findings: there is public benefit in closing the herein described section line; that said section line has not been used for over ten years; that said section line is not traveled due to natural obstacles or difficulty of terrain and/or readily accessible alternate routes of travel; that said section line does not deprive adjacent land owners of access to the landowners' property; and that after closure said section line may be used to benefit of adjacent landowners; and

WHÉREAS, Commissioner Scanson moved to approve closure of the section lines requested by Petitioners and Commissioner Copenhaver seconded the motion, and having been submitted to a roll call vote of the elected County Commissioners:

Resolution passed. Discussion continued to work needing to be completed on the Foster County Tower. Commissioner Roller motioned to allow county officials to install the ties on the tower and to pick up the necessary equipment, seconded by Commissioner Copenhaver. All voted aye and

the motion passed. Commissioner Hagel had contacted three local painters to touch up the stairwell area. Only one provided an estimate. Lois Clark submitted an estimate for \$975.00. Commissioner Copenhaver motioned to approve the work with Lois, seconded by Commissioner Utke. All voted aye and the motion passed. During the last BOCC meeting, an update was suggested to the policy manual in section 208 allowing the department head to adjust the annual increase below the recommended amount if they felt that employees were not working to standards. Commissioner Scanson motioned to approve the update seconded by Commissioner Copenhaver. All voted aye and the motion passed. Hagel construction has completed work at the ambulance building for installation of new doors. The old doors could be used in other areas of the building. The BOCC will look into options for the existing doors. The BOCC has concerns with outside entities meeting at the building and requesting employees to arrive prior to their start time or staying later than scheduled work time. Roundy will work on a policy to present to the BOCC. Commissioner Copenhaver motioned to publish the county right-of-way encroachment notice in the paper, seconded by Commissioner Scanson. All voted aye and the motion passed. With no further business, Madam Chair Hagel adjourned the meeting at 5:12

#### **PUBLIC HEARING AUGUST 5, 2025**

3:00 pm, Madam Chair Hagel called the Foster County Commission Public Hearing to order. Roll call included Commissioner David Utke, Commissioner Becky Hagel, Commissioner Alan Scanson and Commissioner Pat Copenhaver. Also present was Foster County State's Attorney Kara Brinster, Auditor/Treasurer Ellen Roundy, Foster County Independent Reporter Nathan Price and Residents Jeremiah and Angie Blahna.

Auditor/Treasurer Roundy presented the BOCC with the petition from Jeremiah and Angie Blahna, a memo from Kara Brinster and read a letter on behalf of Jim Blahna. Foster County State's Attorney provided information on closing a section line. One of the following must apply to the line to be considered for closure:

- Not used for ten years
- · Not traveled due to natural obstacle or difficult terrain
- · Not required due to readily accessible alternate routes of
- · Intersected by public highways that cause the section line to be a dead end.

After the section line is closed. it may be used for the benefit of the landowner for agricultural or related purposes; survey or property reference markers may not be disturbed, removed, or destroyed. Pursuant to NDCC 24-06-28, a person may not permanently obstruct the section line without first receiving written permission from the county commission or township board. The counties' easement on the section line is permanent. Should it become necessary to construct a road on a closed section line, the county would have the ability to reopen said section line. Discussion included what the public benefit to closing the section line would be. Jeremiah Blahna stated that Sheriff Johnson thought this would be a reasonable route to take to keep the peace and for public safety.

. With no further business, Madam Chair Hagel adjourned the meeting at 3:21 pm.

### SPECIAL MEETING

August 13, 2025 At 8:00 am, Madam Chair Hagel called the Foster County Commission Special Meeting to order. Roll call included Commissioner Paul Roller, Commissioner David Utke, Commissioner Becky Hagel, Commissioner Alan Scanson and Commissioner Pat Copenhaver. Also present was Foster County State's Attorney Kara Brinster, Auditor/Treasurer Ellen Roundy, Road Superintendent Nate Monson, Stutsman/Foster Emergency Manager Jessica Moser, Foster County Independent reporter Nathan Price and Michael Rivinius with Wold Engineering.

The first item on the agenda was information for repairs at the Grace City Shop. Central City Lumber provided an estimate of \$14,129.97 for materials. Monarch Handyman provided a labor estimate of \$20,000. Commissioner Alan Scanson will visit with agent Hooey on where the appraiser is at on an estimate.

The special meeting moved to executive session at 8:04 AM and was attended by Commissioner Roller, Commissioner Utke, Commissioner Hagel, Commissioner Scanson and Commissioner Copenhaver. Also present was Foster County State's Attorney Kara Brinster, Auditor/Treasurer Ellen Roundy, Road Superintendent Nate Monson, Stutsman/Foster Emergency Manager Jessica Moser and Michael Rivinius with Wold Engineering. The executive session ended at 9:38 AM. Foster County Independent Reporter Nathan Price joined the open session of the special meeting. Consensus from the executive session is that Foster County is going to continue to gather data to support their numbers. Wold Engineering will assist with further documentation of road damage. Commissioner Copenhaver motioned to allow Commissioner Scanson to contact the Public Service Commission for the full board of Foster County Commission to meet with the PSC in a special meeting, to allow Foster County State's Attorney to contact the governor's office to meet during the special meeting with the PSC, to allow Commissioner Utke to contact local legislators and to allow Commissioner Hagel to contact NDIRF now for direction if negotiations fail, seconded by Commissioner Utke. All voted aye and the motion passed.

With no further business, Madam Chair Hagel adjourned the meeting at 9:43 am.

Demo on the old Wright Bridge will begin on September 15th and could be completed as early as October 1st but must be completed no later than November 7th. Additional discussion included the flex funding project and what

percentage the county is willing to contribute to the application. Monarch Handyman submitted a quote for \$20,000 for repair work on the Grace City Shop. Central City Lumber provided a material estimate of \$14,129.97. Discussion included bringing water to the building. Commissioner Copenhaver would also like to look into building a new shop in Grace City. Roundy provided information from NDIRF on insurance coverage. The building was under insured so that reduced the claim by around \$8,000. After receipts are turned in, the county could recoup about half of that amount. Commissioner Roller motioned to accept the quote from Monarch Handyman and Central City Lumber for repair work on the Grace City shop roof, seconded by Commissioner Scanson. Roll call vote included:

Matthew Duchscherer applied for a permit at Juanita, Corey Smith applied for a permit in Longview Township, Titus Timm applied for a permit at Juanita, Brian Oster applied for a permit at Juanita and Taylor Sabinash and Chaz Bauer applied for a permit in Nordmore Township. Commissioner Copenhaver motioned to approve all building permits, seconded by Commissioner Utke. All voted aye and the motion passed. Evans also stated that the Planning and Zoning board held a public hearing for the addition of equipment on the existing T-Mobile tower located in the NE 1/4 of 17-146-62. No one from the public attended the meeting and the Planning and Zoning board approved the conditional use permit. Commissioner Scanson motioned to approve the conditional use permit seconded by Commissioner Copenhaver. All voted aye and the motion passed. Evans updated the BOCC on a campground that appears to be taking shape at Kvamme's without proper licensing or permitting. February 20th, 2024, Jeff Kvamme attended a planning and zoning meeting regarding a proposed 24-unit campground project. The planning and zoning board approved the project under the stipulation that Kvamme completes the necessary documentation and provides records to Evans, the proper documentation has not been turned into Evans or the State Health and Human Service department.

Ellen Roundy, Auditor/Treasurer, asked for a motion to add new hire Katlyn Smith to the Foster County bank signature cards and remove any obsolete employees. Commissioner Copenhaver motioned to approve Katlyn Smith to Foster County signature cards and remove old employees seconded by Commissioner Utke. All voted aye and the motion passed.
