Washburn falls just short in 2-1 loss to Post 144 Knights

Despite a complete game performance on the mound from Hunter Hoffman and a late push in the sixth inning, Washburn American Legion Post 12 baseball team came up just short in a 2-1 loss to the visiting Post 144 Knights, June 26.

The game was a defensive battle from start to finish, with both teams combining for just six hits and four errors across seven innings.

Post 144 capitalized early, scoring one run in the top of the first and another in the second. Those two early runs proved to be all the offense the Knights would need, thanks to a strong showing from their own pitching and timely defensive stops.

Washburn struggled to get going at the plate, managing just two hits on the night, singles from Alex Retterath and Charles Sannes.

Retterath also drew one of the

team’s two walks, with Hunter Wolff collecting the other.

Post 12’s lone run came in the bottom of the sixth inning, cutting the deficit in half, but the rally stopped there as the Knights held firm in the seventh to close out the win.

While the offense struggled, Washburn’s pitching was a bright spot.

Hoffman delivered a gritty performance, tossing all seven innings without allowing a walk.

He gave up four hits and two unearned runs while striking out five.

Washburn’s defense committed two errors behind him, which allowed both of the Knights’ runs to cross the plate.

The Knights also committed two errors but were able to limit the damage and strand Washburn runners when it mattered most.

With the loss, Washburn drops a tight contest despite a strong showing on the mound and in the field.

The team will look to bounce back offensively as they continue through their summer schedule.

If Hoffman’s performance is any indication, Post 12’s pitching staff gives them a solid foundation to build upon moving forward.
