William McCone moved to pay Myron Schaff as athletic director one salary with years' experience and one base salary. Jason Krizan seconded. MCU.

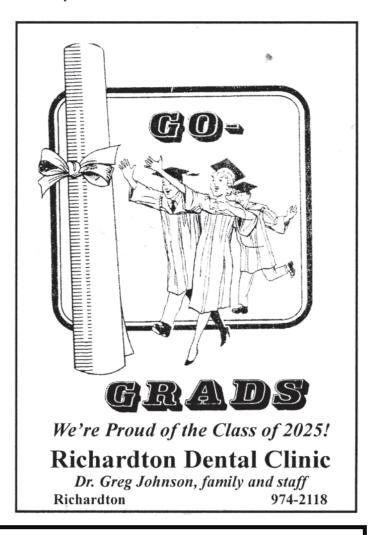

There being no further business meeting adjourned at 8:40 PM. Dave Kraenzel

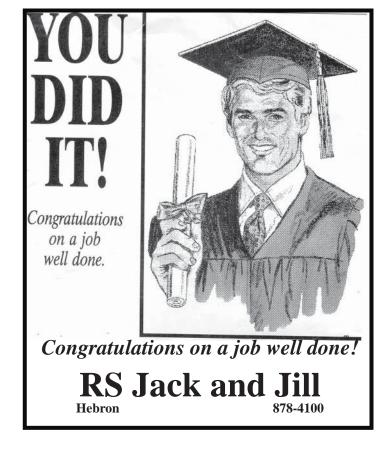
