MINUTES OF A REGULAR MEETING OF THE CITY COUNCIL CITY OF KULM, NORTH DAKOTA MAY 12TH 2025

The Kulm City Council met for their regular meeting on May 12th 2025 at 6:30 pm at the Kulm Community Center.

Community-Andrew McDermid,Tad Anderson, Brandy Little, Le Eslinger and Ruth Schott
Mayor Dale Gackle called the meeting to order at 6:30pm.

Minutes: Councilmen Zeb Mahin made a motion to approve the April minutes from the regular meeting, Vice President Ben Pesek second that motion, all in favor said aye. Motion carries.

Ruth Schott- Ruth presented council with information in regards to a potential walking path. Ruth went into detail with explaining the benefits, permission, plans, funding and routes of the path. Council gave feedback on funding and interest in the path. Advice was given on grants and sponsors that may be available. Council supports the decision if funding is available.

Tad Anderson- Tad was present to discuss the land the city owns that will be going up for bids and requested information on how the bid process will work, and a time line of the sealed bids. Bid discussion was had and will be posted in the paper with the sealed bids being opened at the June 9th meeting 2025.

Mayor: Mayor Gackle discussed the new bill that will be going in effect regarding golf carts. He read the current bill and the new bill to the council. Attorney Radermacher was present to answer questions regarding the new bill. The first reading of the new golf cart ordinance will be read on August 11, 2025 once the new bill has been put in motion. Attorney Radermacher will be working on the new ordinance that will be in place. Mayor Gackle presented council with a bid from Sweeper pro for \$3200.00 to come and sweep city streets, since the city street sweeper does not pick up leaves. City will be notified day in advance to move property off streets. After review of bid councilmen Zeb Mahin made a motion to approve the bid, to have Sweeper Pro sweep the city streets, seconded by Vice President Ben Pesek. All in favor said aye motion carries. Mayor Gackle contacted the county highway department to order one load of tar for chip sealing in July. Mayor Gackle reports pot hole patching and signage will be complete this month. Council answered all questions regarding location of signage. City Auditor: Auditor Holmgren asked council for a motion to designate Kulm Messenger as the official newspaper of the city. Councilmen Zeb Mahin made a motion to approve the messenger as the official paper, seconded by Vice President Ben Pesek, all in favor said aye. Motion carries. Heartland State Bank securities were reviewed. After review councilmen Zeb Mahin made a motion to approve the securities, seconded by Vice President Ben Pesek, all in favor said aye. Motion carries. Karp presented council with a gaming license renewal. After review Councilmen Zeb Mahin made a motion to approve the gaming license, seconded by Vice President Ben Pesek. All in favor said aye , motion carries. Auditor Holmgren found unclaimed property to claim for the city. Mayor Gackle signed paper work giving her permission to collect on the cities behalf. Auditor Holmgren presented council with building permits, Arlene Miller, James Rutschke, Eric Geiszler, and KCDC.

After review councilmen Zeb Mahin made a motion to approve all building permits, seconded by Vice President Ben Pesek all in favor said aye, motion carries. Building Permit from Bushard was reviewed and denied. Councilmen Zeb Mahin made a motion to deny the fence permit due to ordinance violations, seconded by Vice President Ben Pesek all in favor said aye motion carries.

Public Works: Vice President Ben Pesek spoke with council on behalf of KCDC regarding side walk and curb stop for new building. Cleanup week started today and dumpster already had to be cleaned out. Please ask direction on what is allowed in the dumpster. Dandelion spraying is up to each home owner. Letters will be served by the sheriffs Department to residents with uncut lawns, and abandoned vehicles.

Kim Radermacher: Kim Radermacher updated council on Lucille Fercho case and also gave an update on the judgment against Trevor Hanson. Council discussed their options.

Claims: Claims for the month were reviewed and signed. Councilmen Zeb Mahin made a motion to approve all claims, seconded by Vice President Ben Pesek, all in favor said aye. Motion carried.

May Highlights Safe Boating

A week-long national safe boating public awareness campaign is May 17-23, an annual event that serves to educate boaters and water users heading into summer. A boat should have enough U.S. Coast Guard approved wearable life jackets on board for all passengers. North Dakota law requires all children ages 10 and younger to wear a personal flotation device while in boats less than 27 feet in length. The law also requires all personal watercraft users to wear a life jacket, as well as anyone towed on skis, tubes, boards or other similar devices.

However, state law allows an individual engaged in barefoot skiing or surfing to wear a wet suit (a life preserver must be on board the towing vessel), and a person who is at least 16 years of age can windsurf or boardsail without wearing a PFD.

Water users should make sure to wear life jackets of the appropriate size and in good condition. Failure to wear a personal flotation device is the main reason people lose their lives in water recreation accidents. Water skiers and tubers should wear a life jacket with four nylon straps rather than one with a zipper, because straps are stronger than zippers upon impact with water. Anglers and people paddling a canoe, kayak or paddleboard should opt for a PFD that is comfortable enough to wear for an entire outing.

It is also important that children wear a PFD while swimming. Swimmers should know the water's depth, as serious injuries can occur from diving. Large objects hidden below the water's surface can lead to significant injury.

North Dakota boaters are also reminded that Class A and Class 1 vessels are required to have one hand, mouth or power-operated whistle audible for at least one-half mile. This regulation also applies to kayaks, canoes, paddleboards and jet skis.

In addition, marine VHF radios are an important part of boat safety that should not be improperly used by operators. These radios are intended for boat operators in distress and facing an emergency. Regulations to help ensure safe boating this summer are found in the North Dakota Boat and Water Safety Guide.
