City of Medora Minutes of Regular Meeting June 3, 2025 (Subject to Council review

and approval) Meeting was called to order at 7:00pm by Mayor Derwin Zuroff. Present were Council Members Tracy Sexton, Douglas Ellison, Clarence Sitter, Administrator Ivy Maus, City Engineer Shannon Hewson, and City Attorney Sandra Kuntz.

Minutes from May 6, 2025 were reviewed Sitter made a motion to approve the minutes from May 6, 2025, Ellison sec-onded. Motion passed unanimously. Johnson abstained from voting due being absent from meeting on May 6, 2025.

Department Reports

City Engineer Shannon Hewson – requested approval to move forward with submitting the "Construction" funding application, council agreed it is important to continue the application process so they have guidance on how to move forward. Hewson updated on other items/projects that are currently being worked on.

City Attorney Report – City Attorney Sandra Kuntz addressed the first reading of the change to our signage ordinance 02-2025 incorporating bullets about digital and electric signs. Sitter made a motion to approve the second reading

with those changes, Sexton seconded. Motion passed unanimously.
