Joey Puettman, from Sheridan, WY, is a former wrestler who might just be a fly-fishing addict. And as that he's proof that not all addictions are bad.

You see, he has turned his love of fly fishing into a rod building, and a fly-fishing instruction and guiding business. And what might have started as a love for a sport has turned into therapy for a lot of people and counseling for disadvantaged vouth.

In that way, nature is like a filter, and it helps you to realize what is important in life, what vou should focus on and what you're wasting your time on.

Can a little fishing trip to a nearby

stream do all of that? Absolutely.

Now, I went fishing with my family a fair amount in my youth. But fly-fishing is a whole different activity simply because you are doing your best to duplicate the activities of a fly (at the end of your fly-fishing line). You see, you want to make it just tap the surface of the water and tempt a fish that happens to be in the right place at the right time to devour it along with your hook.
