Notice is hereby given that on the first Tuesday of June, being June 3rd, 2025, an annual election will be held for the New Rockford-Sheyenne School District No. 2, counties of Eddy, Foster, Wells, and Benson, State of North Dakota.
Polling place will be the lobby of the New Rockford-Sheyenne Public School gymnasium, north entrance, in New Rockford. The polls will be open from 11:00 a.m. to 7:00 p.m.
The election shall be held for the purpose of electing two school board members for three-year terms. One member will be elected to a three-year term from the former New Rockford District, and one will be elected At Large from anywhere in the district.
Candidates for each school board seat is determined by residency within defined geographic areas of the district, but all eligible voters of the school district may vote for each position.

The candidate will also be required to complete a Statement of Interest form. A statement, which if mailed, must also be in the business manager's possession by 4:00 p.m. on March 31st, 2025. Both forms are available in the school Business Manager's office.
