priority would be clearing out the city's impound lot, which is currently full with around 10 vehicles. That process will begin with notices being sent out and a 30-day redemption period, after which the impounded vehicles could be

Once the impound has more room to hold vehicles, notifications for the junk vehicles within city limits would go out, with the expectation that some will finally be taken care of.

Regarding junk on private properties, the commission will be holding a special with ICE. meeting on Tuesday, May 20 - shortly after the conclusion mines next steps. These offiof this year's spring clean up and curbside pickup, which takes place from Monday, May 12 - Friday, May 16.

On May 13 the city will pick up tires and appliances, and on May 14 and 15 they'll be picking up furniture only. Any items left on the boulevard at that point should be

taken to the landfill on May 17 from 9 a.m. to 2 p.m. by the property owner.

Commissioners said this will give those in violation of the junk ordinance an opportunity to get back in compliance.

Commissioners said they'll be working with the Eddy County Sheriff's Office and will seek a warrant when it comes time to remove junk or vehicles from private property.

Also during Monday's meeting, commissioners received a brief update regarding the city hall discussion, and whether the city will be renovating their current building, purchasing a new one or building their own.

Richter said they're still waiting for a price estimate for what it would take to build a brand new city hall, which they could compare to the price of renovation and purchasing a different building.

Richter said he hopes they can get that estimate by their June meeting, at which point they could potentially make a decision.

The city's next regular meeting is scheduled for 9 a.m. on Monday, June 2, in City Hall.

The partnership, Lies said, will enable the Eddy County Sheriff's Office to "better serve and meet the needs of the residents of Eddy County."

Lies signed the standard contract distributed to all law enforcement agencies at their request and said he's now waiting for ICE and DHS to approve his agency's ad-

mission into the program. He said there is the potential for the federal government to provide training at a reduced cost and reimburse his department for enforcement work undertaken while enrolled in the program, but the details are unknown at this time.

The new Axion body cameras are in the field, and they seem to work really well, Lies said. Funds for the new equipment were provided by the New Rockford Eagles Club and the New Rockford Lions Club, with the remaining cost to be paid by the department over five years.

Lies is pleased with the functionality of the cameras, as well as the support available from the company. When the lights of the officer's vehicle go on, their body cam starts recording.

When the officer returns to the vehicle after a stop or a call, the video footage captured by the camera is automatically uploaded to the vehicle's computer system.

The new technology allows the officers to instantly send video to the state's attorney, who can then forward them directly to the defense attorney.

The old system requiring flash drives and data transfer was not ideal. They are also able to use software to redact portions of a video to protect the identity of juveniles as required by law.

The department is now fully staffed, and a new squad car has been ordered. Lies said the process of equipping a car for service takes 4-5 months, as the firm they use is reputable and sought after by sheriffs, chiefs of police and highway patrolmen
