from a pole. Equestrian events, rapier and armored combat and atlatl throwing during a torchlight tournament are all planned.

This will be the fourth Bardic Blades event Neal has attended, and he has gained from his involvement in the SCA, he says.

“I’ve learned a lot through it, not just personal history, but I’ve also learned to be a better person through it,” Neal says. “We have a lot of people from a lot of different walks of life within the organization.”

Participants have interests ranging from history buffs to martial arts or riding horses, but become like family as they gather at events and share their like interests, he says.

“There are a couple of ways to start out, but if you are a big history buff, that is definitely one avenue. If you want to do the martial arts stuff, like the rapier fighting, the heavy combat fighting or just shooting an arrow, or even riding horses, that’s another way to get in. We also do period games. I love cribbage, but for me to play the period game, I have to play noddly, which is the precursor to the modern-day cribbage,” Neal says.

“For me, this is a great organization, because I get to do so

many activities to the point where sometimes it’s really difficult to pick and choose,” he says.

“If people are looking to do something other than the normal with people that have like-minded interests, definitely look up the SCA,” Neal says.

PASTOR’S NOTES

Pastor Paul Ferrie,

Grace Reformed Church of the Lord Jesus

After several months, we resume our study of Colossians now in verse 5 of chapter 3: “Therefore put to death your members which are on the earth: fornication, uncleanness, passion, evil desire, and covetousness, which is idolatry.” The apostle Paul has previously taught that each believer is in union with Christ in His death, burial, and resurrection. Because of that, he or she is to seek to live a life of holiness, depending on the enabling power of the Holy Spirit. Our verse states some specific areas that the believer is to put away in that pursuit of holiness.

The word translated “members” refers to sins which the sinful nature that remains in the Christian uses the body to commit. The apostle Paul frequently refers to the believer’s body as that which can be used as an instrument for either righteousness or for unrighteousness. Thus he writes in Romans 6:13: «And do not present your members as instruments of unrighteousness to sin, but present yourselves to God as being alive from the dead, and your members as instruments of righteousness to God.”

Throughout history, many have made serious mistakes in trying to apply the command of our verse. We saw in Colossians 2 that false teachers were advocating extreme forms of asceticism in attempts to become more spiritual. But note Paul’s response in Colossians 2:23: “These things indeed have an appearance of wisdom in self-imposed religion, false humility, and ne-

glect of the body, but are of no value against the indulgence of the flesh.” Early in the monastic movement some practiced severe self-denial and self-inflicted pain in attempts to curb the sinful lusts of the body.

But what Paul has in mind when he tells us to put to death our members which are on the earth is to have transformed minds and renewed wills which focus on God’s Word and which realize that through union with Christ the believer is not what he or she used to be. In other words, we should seek to become what we are as new creatures in Christ. A Christian in our day needs constant vigilance in the battle to put to death his members which are on the earth, and we would have to question the reality of newness of life in one who is not seeking to do so.

Next time, Lord willing, we shall consider specific sins that are to be put off. But I close by reminding us of a very important distinction. Putting away sins must be the RESULT of having been born again and becoming a new person in Christ. It must never be confused as being a way to ATTAIN forgiveness and salvation. We are made right with God through faith in Christ alone. Good works, including putting off sins, will FOLLOW as an inevitable result of salvation, but please do not forget Ephesians 2:8-9: “For by grace you have been saved through faith, and that not of yourselves; it is the gift of God, not of works, lest anyone should boast.”
