Commissioner Hochhalter moved to approve agenda, seconded by Meyer. All present voting aye; agenda approved.

Moved by Meyer and seconded by Hochhalter to approve August 20, 2025 Regular Board of Commissioner meeting minutes. All present voting aye. Minutes approved.

Auditor Meier mentioned the breakage of a window in the courthouse. Discussion on window replacement for courthouse and request for proposal will be made. Companies that work with industrial window replacements will be contacted.

Sheriff Terry Dillon presented letter to request the reinstatement of the fourth deputy position in the 2026 budget.

Commissioner Meyer asked if the possibility of having four deputies gave the department hope. Sheriff Dillon said yes and elaborated. Having two deputies respond leads to officer safety. The Board discussed reversing the decision to limit the Sheriff Department to only three deputies. It has been difficult to find candidates. Hochhalter said if four acceptable candidates can be found, to allow the department to hire the fourth deputy, and the general fund will accommodate.

Jon Alt gave update on equipment repairs.

Auditor Meier presented the Service Contract with The Sidwell Company to provide Geographic Information Services(GIS). The contract will begin as soon as the contract has been executed. Payment for completion of work will be invoiced monthly. The entire contract is \$75,795.00 covering a five year period. The first year cost for parceling, data conversion and soil database development is \$49,405.00. GIS is a necessary tool involved in the valuation of agricultural land for tax purposes. Motion made by Meyer and seconded by Hochhalter to approve agreement with Sidwell Company. Roll call vote - Hochhalter – aye, Meyer – aye, Zenker – aye. Motion carried.

Motion made by Meyer and seconded by Hochhalter to renew certificate for deposit #0221 for a 24-month term with the applicable rate at Dakota Community Bank & Trust. Roll call vote - Hochhalter – aye, Meyer – aye, Zenker – aye. Motion carried.

Treasurer report was reviewed and accepted.

Being no further business, Zenker adjourned meeting at 12:54 p.m. FYI: next scheduled meetings will be September 17th and October 1st, 2025. Budget hearing is scheduled for September 10th, in the Courtroom of the Grant County Courthouse at 9:00 a.m.

PUBLIC NOTICE TO GRANT COUNTY LANDOWNERS OR OPERATORS

Notice is hereby given to all landowners or operators to cut all weeds and grasses adjoining their lands to a maximum of three inches along those roads defined as roadways by Grant County Board of Commissioners including weeds and grass growing within the public right-of-way bordering such highways and their lands. Such cutting shall be October 1, 2025. Cutting with a swather is not adquare and a minimum of 13 feet must be cut using a mower. If the weeds and grasses are not cut along county roads or if cut and not cut adequately to prevent snow building, the county will mow the weeds and grasses and charge the adjacent landowner at a rate of \$250.00 per mile. The actual cost shall be charged against the land or the landowner and shall become part of the taxes to be levied against the land for the ensuing year. Also, if hay or bales remain in the ditches of county roads after November 1, 2025, the county will remove the hay bales and the landowner may redeem them by paying the cost of removal.
