FEMA about including some additional work south of the 2nd Street culvert drainage project where a resident has had some water issues in her basement. This additional work could not be included in the project until the culvert project was completed, including the pavement. The city has decided to cover this work themselves.

Public Works Director Randy Dietz gave his report next. He asked the council if they would reimburse the new employee for cell phone use in connection with his job, which the council approved.

Council member Tom Marman inquired about how many water meters need to be replaced in the city. He stated that this should be put higher on the list of things to be done.

Auditor Kim Gaugler gave her report next. She updated the Council on the tourist center. Jan Kuchera and Maria Marman will man the center this season.

Another item was the ordinance dealing with storage containers in the city. After a discussion, the ordinance was passed that would not allow them in residen-

tial areas except for construction work.

A request for Community Enhancement funds for the Sentinel Butte Hall was received. They are doing some work on the HVAC in the hall and were requesting any assistance they could receive from the fund. After discussion, the Council approved a \$1,000 payment.

The Golden Valley County Fair Board requested a permit to hold a chicken bingo game during the fair. The Council made the motion to approve the request.

A request from St. John the Baptist Church to block off Main Street from Central Avenue one block east for a Family Fun Night on June 21st was approved by the Council.

There was also a request from Dobré Brewhouse for a permit for an event that same evening. This was also approved by the Council.

As there was no further business before the Council, the meeting was adjourned.
