FPS has been a National Connection (Nat Con) member of NSBA since August 5, 1975 The Nat Con membership is an annual membership, from July 1 through June 30. The membership provides for use of a national directory of Nat Con participants, registration discounts, and resources including the American School Board Journal (ASBJ), National Connection Daily, ASBJ Brief, Legal Clips, Federal Advocacy Insider and webinars. For numerous years, the an-nual membership fee to be a Nat Con member was \$5,335. For the 2025-26 school year, the Nat Con fee for FPS would be \$8,620. COSSBA was found-ed in 2022. The NDSBA is now a state member of COSSBA. At this time, COSSBA does not offer a membership similar to the Nat Con membership for school districts.

Both associations offer annual conferences for school board members to attend. The NSBA 2026 conference will be in San Antonio, April 10-12. The COSSBA 2026 conference will be in Louisville, March 13-15. The Gover-nance Committee discussed and weighed the benefits of being a Nat Con member of NSBA, and the conferences of both associations. The committee reached consensus to bring to Board a recommendation to end the NSBA National Connection membership as of June 30, 2025.
