West Fargo utility fees going up once again

WEST FARGO — Utility rates in West Fargo will go up once again in 2026 as part of a five-year Public Works plan to "catch up" on fees.

West Fargo city commissioners recently approved new garbage recycling, sewer and water rates for 2026 ahead of the city's annual budget process.

The rate changes mean the bill for an average residential utility customer who uses about 6,000 gallons of water and has a 64-gallon garbage bin will go from \$128.81 per month to \$142.88 per month.

Water rates will increase from \$54.23 per month to \$55.86. Sewer rates will increase from \$47.03 to \$56.62; sanitation will increase from \$23.55 per month to \$25.90 per month; forestry will increase from \$3 to \$3.50 and the monthly vector fee will stay flat at \$1 per month. Public Works Director Matt Andvik said the 2026 utility rate increases are the second part of a three-year plan to increase rates in the city following a period without increases between 2020 and 2024.

water from the city of Fargo and also sends its wastewater to Fargo as it works to decommission the West Fargo lagoon system. Andvik said Fargo is expected to raise its water rates in 2027 and 2029.

"Bringing it back every year, we are able to see what is going on and can adjust," Andvik said. "I think it works going forward, especially when we are getting these increases from Fargo. If the increases come in less than we are expecting, we will be able to lower those increases. If that is higher, we may have to adjust for that, as well.'

He noted the increases also help West Fargo prepare for continued expansion that is expected to gain traction on the north side of the city after the completion of the F-M Area Diversion.

Hog roast in **Pelican Rapids** to raise money for HIA Hospice

PELICAN RAPIDS, Minn. — An event in Pelican Rapids early next month will raise money for a Fargo hospice facility.

The 10th annual JJ's Hog Roast for Hospice will generate funds for HIA Hospice, formerly Hospice of the Red River Valley.

The fundraiser takes place at 51943 County Highway 9 in Pelican Rapids, a quarter mile north of Zorbaz on Pelican Lake, on Saturday, Aug. 2, according to a news release. A free-will donation is encouraged for the event, which begins with a hog roast dinner at 11 a.m. The Show & Shine car show runs from 11 a.m. to 3 p.m. There is a \$15 donation as the entrance fee for the car show. Side x Side UTV/ATV mud races start at 12:30 p.m. Throughout the day, a kids bounce house, holein-one golf challenge. mobile escape room and silent auction are available. Entertainment begins at 7 p.m., including a DJ service and laser light show. Free, overnight primitive camper and tent spots are available for those who don't want to drive home after the event, the release said. Since its first year, the event has raised more than \$106,000 for the hospice organization, the release said.

"This is year two of a catch-up," Andvik said. "We had zero increases since 2020. ... From here on out, the increases will be a lot less."

In 2025, the city increased water, sewer and garbage fees after Andvik requested the rate increases to ensure the department had sufficient reserves to cover unexpected costs.

Andvik said the increases will help strengthen the Public Works sanitary reserve funds and modernize collection operations. It will also help keep up with the rates the city of Fargo charges for garbage disposal and water.

West Fargo buys its

Department hopes to develop a long-term waste disposal strategy for the next 10 to 15 years. West Fargo pays to take its garbage to the Fargo landfill, where rates for West Fargo are expected to increase by about \$6 per ton in 2026, Andvik said.

West Fargo's utility rate hikes will also help the forestry department build its reserve funds and plan for long-term projects, he said.

Andvik said the department is responsible for 21,000 boulevard trees in the city of West Fargo. The forestry department also works to eliminate and protect the city's trees from the invasive and tree-killing emerald ash borer.

West Fargo commissioners approved the rate increases at their July 21 meeting with Commissioner Roben Anderson voting against the increases.

The 2026 utility rates will go into effect Jan. 1.

Canadian wildfires to bring smoky air to Minnesota

ST. PAUL — Another round of smoky air will cover the vast majority of Minnesota through Friday, the state Pollution Control Agency warned in an alert issued Wednesday afternoon.

The alert, which covers virtually all of the state excluding the Rochester

conditions, neart disease, high blood pressure or diabetes, pregnant women, children, older adults, and people who have increased exposure to the outdoors.
