With 60 days to accept or decline the offer and 6 months to use the funds, if accepted and \$208.33 monthly payments until paid in full. Contingent on accepting the loan before the grant is paid out. Invoices and cancelled checks must be provided to receive funds. By roll call vote: Council Members Haman, Duckett, Nilsen, McIntyre and Lamb voted "aye". None voted "nay". Motion carried. The second application was for Nilsen Oilfield Supply. Moved by McIntyre and seconded by Duckett to approve the recommendation of the Sales Tax Committee of a \$8,000 grant and a \$12,000 interest free loan for inventory. With 60 days to accept or decline the offer and 6 months to use the funds, if accepted and \$333.33 monthly payments until paid in full. Contingent on accepting the loan before the grant is paid out. Invoices and cancelled checks must be provided to receive funds. By roll call vote: Council Members Haman, Duckett, McIntyre and Lamb voted "aye". Nilsen abstained. None voted "nay". Motion carried. Property Bid Opening: There are still discussions taking place with Renville County pertaining to the purchase of the old city hall property on Main Street. Mayor Witteman met with the County Commissioners to discuss options. This subject will be on the June agenda to finalize the process. Site Authorization: Moved by Haman and seconded by McIntyre to approve the Gaming Site Authorization from Veteran's Club of Kenmare for Double J's Bar and Grill. All voted "Aye". None voted "Nay". Motion carried. Moved by Nilsen and seconded by McIntyre to approve the Gaming Site Authorization from Mohall Fire Department for Drinks 4.0 LLC. All voted "Aye". None voted "Nay". Motion carried. Moved by McIntyre and seconded by Lamb to approve the Gaming Site Authorization from Lansford Jaycees for Cheers II Ya LLC. All voted "Aye". None voted "Nay". Motion carried. Resignation: Bob Marmon submitted his resignation as the Mohall Community Center Maintenance Personnel. Moved by Nilsen and seconded by Duckett to accept Marmon's resignation as of June 1, 2025. All voted "Aye". None voted "Nay". Motion carried. Discussion was held to not fill his position as it was, but to hire someone to clean after each event. City Council members and Public Works will work together for now to manage the rest of the rental duties. There is also a need for janitorial at the fairground's bathroom. Moved by Nilsen and seconded by Lamb to advertise for janitorial personnel for both the Mohall Community Center (as-needed) and the fairgrounds bathhouse (seasonal) at \$18.00 per hour. Dakota Datebook

Novelties always seem to sell well, a fact as true today as it was in the distant past. One of the odd novelties from about one hundred years ago was a fellow named Jack Williams, who called himself the "Human Fly."

On this date in 1921, the Grand Forks Herald reported that Williams had successfully climbed to the top of the local First National Bank building. So many people gathered to watch that five police officers were assigned to handle the throng. It was so crowded that some of the spectators climbed the sides of nearby buildings to find a vantage point.

Jack Williams said that the "smooth walls" of the bank building made this climb the "most difficult he ever made." When he got to the roof, he "straddled the top of the flag pole," and slapped the golden ball above the flag

After scaling the bank's walls, the Human Fly went to the Fotoplay Theater to appear in a vaudeville review, where the delighted audience gave him a "five minute ovation."

Much hype surrounded the Human Fly's appearance in Grand Forks. His advance man, C.C. Brown, informed newspapermen that Williams had been climbing buildings for over eleven years. He was said to use the smallest indentations as hand holds, and had such strong hand muscles that he could crush a "raw potato into pulp" with one squeeze. Promoter Brown boasted that Williams was the " original human fly" and that over 500 men who wanted to be a "human fly" had died trying to match Williams' accomplishments, which included climbing all 60 stories of New York City's Woolworth Building - the tallest building in the world at the time.

Doubters had scoffed at this boasting, informing Mr. Brown that previous "human flies" had failed to perform in Grand Forks - one "Fly" saying the weather was too cold and stormy before slinking away. Immediately, promoter Brown told Jack Williams to climb the Herald 's building, and the Fly scrambled up four stories in less than four minutes, silencing the "Doubting Thomases" and building anticipation for his climb of the bank building.

After Grand Forks, Williams took his death-defying feats west, clambering up tall buildings in Minot and Valley City, keeping North Dakotans buzzing over his stick-to-it-ive-ness and his dazzling disregard for dizzy danger.
