Black Mountain billing software upgrade was discussed. The BMS Pay would allow customers to pay online with either ACH or credit cards. Payments would automatically be posted to their utility billing account in real time. The software upgrade would be \$5,930.00 for the first year, then \$4,595.00 per year after that. The council discussed, and determined the cost was too high for the usage they would see for the service.

Jim Burton discussed with the council the change in the late fee, for utility billing, that was recently implemented. His concern that with the \$20.00 late fee, it ends up being a high percentage of his overall bill. He also expressed his concern with the city, with the city water, and that the water is unhealthy for residents to drink. Garrett also discussed the steps to be added to the agenda for city council meetings. Kristy gave him the information to email to do so.

Gaming applications were submitted to the Kenmare Vets Gaming, and also to the Mohall Fire Department. One will be submitted to the Tolley Fire Department. For costs for the Sherwood Gym.

Discussion was held on a local group possibly doing the local gam-
