MLS Basketball Opening Game Round Up

The MLS Girls Basketball team opened up their season on Tuesday, December 2nd, hosting the Divide County Maroons. MLS jumped on the Maroons early racing out to a quick 7-

0 behind 2 free throws and a basket from Laney Varty and a basket and one from Cloe Weathers.

DC scored the next four points before Archer Ackerson answered with two field goals to make it 11-4. It was 11-7 midway through the first

quarter when MLS went on an 17-2 run behind a relentless full court defense, great passing, and hot shooting.

A three pointer by Trapper Ackerson, two field goals by Hattie Varty, a three by Archer, and buzzer beating three by Laney gave MLS a 28-9 lead after the first quarter. MLS continued their strong play into the second quarter, holding DC to just three points in the quarter and putting another 20 on the board for themselves. Two more threes from Archer and Trapper along with six and four points from Hattie and Laney gave MLS a 48-12 advantage at halftime. DC outscored MLS 14-13 in the third and 8-6 in the fourth, but MLS went on to win the game 67-34. MLS finished the game shooting 54%, going 5/7 on threes for 71.4%.

They were 10 of 17 from the free throw line for 59%, had 38 rebounds(14 offensive), 17 assists, 16 steals, and 21 turnovers. DC finished the game shooting 26% and were 2 of 9 on three pointers for 22%. They were 10 of 14 from the free throw line for 71%, had 21 rebounds, 4 assists, 13 steals, and 25 turnovers. Leading scorer for DC was Jurnee Wehrman with 18(2-3's).
