Special Assessment List Appears In This Issue

A list of special assessments for Napoleon property owners can be found on a number of pages throughout this issue.

The pending assessments are required to be published to possibly assist with the payment of a \$2.3 million water improvement project along with street improvements which took place on 3rd Street East in Napoleon in 2023.

The assessment list includes the total amount being assessed, based on square footage. Prior to moving forward with the improvement project the Napoleon City Council had approved paying for the project from the city water fund over time.

However, stipulations of funding have the project being assessed to property owners in the event the city were to default on the \$758,000 loan. According to City engineers, Moore Engineering, they issued this statement: "Special Assessments are not intended to be levied against properties unless the city is unable to make logan payments. Assessment certification is required by the project funding agency."

The project was fortunate to qualify for a couple of grants, \$163,400 DWR preconstruction grant, \$1,488,988 DWR construction grant and a \$620,000 Rural Development grant, dropping the local share to \$758,000, which is the amount being assessed across all parcels of property owned within the city of Napoleon.

A public hearing has been set for Thurs., June 5 at 7:00 p.m. at the Napoleon City Hall where residents will be able to present any concerns relating to Water Improvement District No. 2023-1.
