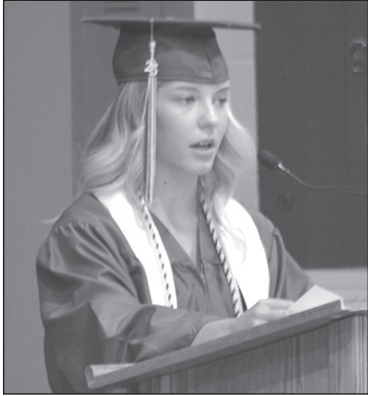

**NOTICE OF FORECLOSURE OF TAX LIEN**
