The Consolidated Plan provides information about the housing and nonhousing community development needs in the state and includes a five-year strategy to address those needs, emphasizing benefit to low- and moderate-income persons and house-

The 2025 Action Plan provides a summary of the actions, activities and specific federal and non-federal resources that will be used during the year to address priority needs and goals identified in the Consolidated Plan and plans for allocating the U.S. Department of Housing and Urban Development CPD formula block grant programs: Community Development Block Grant, HOME Investment Partnerships, National Housing Trust Fund and Emergency Solutions Grants programs.

The Action Plan describes how the funds from each program will be disc

funds from each program will be dis-tributed during the 2025 program year, which is scheduled to begin on July 1, 2025. Funds are expected to be received on or about August 1, 2025.
