The bid security must be in a sum equal to five per cent (5%) of the full amount of the bid and must be in the form of a bidder's bond. A bidder's bond must be executed by the bidder as principal and by a surety company authorized to do business in this state, conditioned that if the principal's bid be accepted and the contract awarded to the principal, the principal, within ten (10) days after notice of award, will execute and effect a contract in accordance with the terms of his bid and the bid bond as required by the laws of the State of North Dakota and the regulations and determinations of the governing body. If a successful bidder does not execute a contract within ten (10) days allowed, the bidder's bond must be forfeited to the governing body and the project awarded to the next lowest responsible bidder.

All bidders must be licensed for the full amount of the bid as required by Section 430707 and 43-07-12 of the North Dakota Century Code

Bidders on this work will be required to comply with American Iron and Steel requirements of the Consolidated Appropriations Act, 2014. The requirements for bidders and contractors under this regulation are explained in the specifications

Bidders are required to comply with Davis-Bacon prevailing wage requirements.

Bidders on this work will be required to comply with Title 40 CFR Part 33- Participation by Disadvantaged Business Enterprises in the United States Environmental Protection Agency Programs. The requirements for bidders and contractors under this regulation concern utilization of Minority Business

Should the Contractor fail to complete the work within the time required herein or within such extra time as may have been granted by formal extensions of time approved by the Owner, there will be deducted from any amount due the Contractor the sum of \$900 per day and every day that the completion of the work is delayed. TODAY IN HISTORY

On April 8, 1974, Hank Aaron of the Atlanta Braves hit his 715th career home run in a game against the Los Angeles Dodgers, breaking Babe Ruth's home run record that had stood since 1935

In 1820, the Venus de Milo statue, likely dating to the 2nd century B.C.E., was discovered by a farmer on the Greek island of Milos.

In 1864, the U.S. Senate passed, 38-6, the 13th Amendment to the U.S. Constitution abolishing slavery. (The House of Representatives passed it in January 1865; the amendment was ratified and adopted in December 1865.)

In 1911, an explosion at the Banner Coal Mine in Littleton, Alabama, claimed the lives of 128 men, most of them convicts leased out from prisons.

In 1913, the 17th Amendment to the Constitution was ratified, providing for election of U.S. senators by state residents as opposed to state legislatures.

In 1962, Cuba announced that 1,200 Cuban exiles tried for their roles in the failed Bay of Pigs invasion were convicted of treason and sentenced to 30 vears in prison

In 1990, Ryan White, the teenager whose battle with AIDS drew national attention and led to greater understanding and de-stigmatization of those suffering from the disease, died in Indianapolis at age 18

In 1992, tennis great Arthur Ashe announced at a New York news conference that he had AIDS, having contracted HIV from a blood transfusion in 1983.
