Shanley downs Hi-Liners in EDC Softball

Fargo Shanley scored in every inning but one enroute to a 14-4 win over Valley City in Eastern Dakota Softball at Shanley.

The Hi-Liners scored in the top of the first to take the early lead. Bethani

Schuldheisz doubled to start the game. With one out, she moved to third on a passed ball. Bailey Leroux walked then Lauren Larson brought in Schuldheisz with a sacrifice fly, making it 1-0 Hi-Liners.

The lead was short lived as the Deacons scored

three runs in the bottom of the first. One scored on an error, one on a passed ball, and one on Emily Anderson's single.

Shanley would add three more in the second inning. One on an error, one on Taelyn Card's sacrifice fly and one on another Anderson single, making the score 6-1 after two innings.

Four more runs came across for the Deacons in the third to take a 10-1 lead, all with two out. A bases clearing, three run double by Card was the big play in the inning. Anderson followed that up with an RBI double.

The Hi-Liners would cut into the lead in the top of the fifth. With one out, Jaye Potratz singled. Then with two out, Kinlee Sufficool was hit by a pitch. Leroux doubled, scoring Potratz and Sufficool to make it 10-3 Shanley. Leroux would score on a passed ball to make it 10-4.

Shanley added two runs in the bottom of



the fifth. Card and Em-malise Maher had RBI singles, making the score 12-4 after five.

The Deacons ended the game with two runs in the bottom of the sixth, both on steals of home. Holly Ovsak was first, then Sarah Sim two pitches later.

Six Hi-Liners had at least one hit. Bailey Leroux was 1 for 1 with a run scored and two RBI. Kinlee Sufficool and Jaye Potratz were both 1 for 2 with a run scored. Bethani Schuldheisz, Ellie Altringer, and Danica Aberle were all 1 for 3. Schuldheisz scored one run.

Valley City is now 4-4 in the EDC and 2-4 overall. They host Grand Forks Red River on Thursday, May 1st at the Valley City State University Softball complex. First pitch is at 4:30 p.m.
