

West Fargo uses two-out rallies to down Hi-Liners

West Fargo used a five-run, two out rally in the top of the second inning to take the lead on the way to a 17-4 win over Valley City in Eastern Dakota Conference baseball at Charlie Brown Field.

The scored three runs on the bottom of the first to take the early lead. Trevor Fetsch led off with a walk, then scored on a double by Corbyn Powell. Jack Samuelson singled to left, scoring Powell to make it 2-0 Valley City. With one out, Leighton Hendrickson walked. Parker Roelfsema singled to left, scoring Samuelson to make it 3-0 Hi-Liners. Andrew Sykora grouned into a 4-6-3 inning ending double play to keep the score at 3-0.

In the top of the second, West Fargo scored five runs, all coming with two out. With the bases loaded and out, Drew Hettenbaugh lined out to center

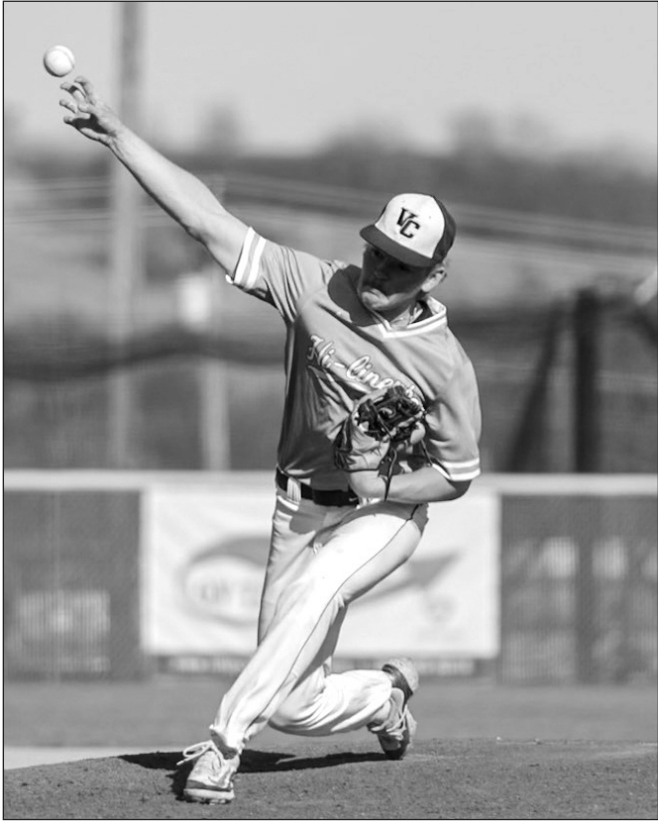
fielder Trevor Fetsch, Owen Haugen tagged up and scored to make it 3-1. Jacob Scholand doubled, scoring Ashton Wigestrاند and courtesy runner Lukas Grensteiner to tie the game at 3-3. Grayden Peterson ground to third, but James Schwehr throw was high and got by Sykora at first, scoring Scholand to make it 4-3 Packers. Brody Medina singled, scoring courtesy runner Payton Schneck to make it 5-3 West Fargo.

West Fargo scored

three more in third, two coming with two out. With runners at the corners and no one out, Wigestrاند reached on a bunt single, scoring Ethyn Bye for a 6-3 Packer lead. A sacrifice bunt by Rigley Matteson put runners at second and third and one out. Hettenbaugh flew out to left field for the second out, but a strong throw by Bodi Haglund kept the runners from advancing. Scholand singled to center field, scoring two runs to make it 8-3 West Fargo.

In the top of the fifth, the Packers scored three times. With runners at first and third and no one out, Wigestrاند stole second, when the throw went into center field, Haugen scored to make it 9-3. Matteson then doubled, scoring Wigestrاند to make it 10-3. Scholand singled in courtesy runner Grensteiner to make it 11-3.

In the sixth, West Fargo scored six runs, all with two out. A bases loaded walk to Hettenbaugh brought in the first run. Wigestrاند
