DAKOTA DATE-BOOK: Minuteman Mis-

July 11: On this day in 1965, more than 2,000 people gathered (such a large crowd on such a small site!) about five miles outside of Michigan, North Dakota. They were going to view a Minuteman missile launch control facility. North Dakota is not generally known for its nuclear activity, but it actually had several Minuteman missile sites. And as it was the midst of a generation poised for nuclear war, an exhibit of this type would hold great interest.

Of course, the Minuteman missiles were not completely installed at the time of the open house. So when the visitors "peered down the open mouth of

an underground silo" that would eventually hold the intercontinental ballistic missiles, they had to use their imagination. More than 2,900 people visited this site over the two-day open house. The first day was reserved for military personnel and their families and for local businesses.

Visitors were to be taken by bus from one and a half miles east of Whitman at the Sherman Moen farm to Launch Facility H-21, where they would visit the underground 'silo' in which the Minuteman missiles were to be stored.

Equipment and displays were set up for the event so the visitors could become more familiar with the construction of and operation of the missiles. Members of the Dads'

A day nursery is what we now call daycare. Nowa-days daycares are so common that nearly every child has attended one. But in 1917, Fargo had exactly one, and it proved to be a very much-needed innovation for the working mother.

As the world modernized during the industrial revolution, many women needed to leave the home to work. Most women

The first day nursery in the United States opened in 1854 in New York. However, the growth of day nurseries was slow and there were only 500 in the United States by 1912.

In January 1917, the Associated Charities of Fargo realized that many working women could benefit from a day nursery. A home near Island Park was rented and Sadie Barrett was hired to run the nursery. It opened on February 19th, accepting children aged 3-weeks to 6-years from 7am to 5pm. The rented home provided a room for Sadie Barret to live in, a playroom, din-

Trump announced several months ago a new promotion that would trade on his presidency: He was hosting a dinner at his Virginia golf club for the top 220 investors in his meme coin, \$Trump, with a special White House tour for the top 25.

The Day Nursery proved so popular that Associated Charities spent \$4,000 to purchase and renovate an old schoolhouse. By August, about 125 children were cared for monthly. By the end of 1918, men who lost their wives to the Spanish Flu were encouraged to take their children to the nursery. Now, more than 100 years later, daycare continues to be a pressing need.
