Lisbon is one of 15 schools that utilize SRCTC for training, staff, and equipment for many fields including Ag Education, Automotive Technology, and Restaurant Management.

Currently SRCTC is aiding Lisbon in finding a second ag instructor.

**Other School News**

- \*Election of board members was set for May 28, 2025. Interested candidates must file by March 25 to be on the ballot. The seats of Tony Kelsen (rural) and Lance Gulleson (city) are up for re-election. Also on the ballot will be the publication of school minutes.
- \*On the employment front, the administration is still looking for someone to fill a custodial position, a cook, and two ELA positions for Middle and High School.
- \*On the legislative front,

Superintendent Justin Fryer reported that he has provided written testimony concerning private school bills. The first foundation aid bill includes a 3% increase in per pupil funding for both years of the biennium and that there have been several property tax plans introduced.

- \*Auditors have completed an on-site visit. The final report will hopefully be done by the March meeting.
- \*Kevin McCleary was named girls' track coach.
- \*Current enrollment is at 597 which is up eight students from the November number.
- \*The next school board meeting is scheduled for Thursday, March 13 at 7:30 pm.
