No, it’s not as wet here as it was a year ago (yet), but the ground is soft enough for you to consider weeding out a few of your overgrown excess perennials -- and then possibly planting a few new varieties. Our West River Health Services Foundation happens to have just the answer for you:

1) Around May 13-15th or so, thin out your perennials; put ‘em in a pot.

2) Bring ‘em to West River Ambulance Garage in Hettinger prior to noon on Friday, 5/16.

3) Come back to the Garage at 2pm that same day to purchase new-to-you, unique perennials and give a goodwill donation toward our Auxiliary Legacy Scholarship. A gardener’s paradise!

That’s right, on Friday, May 16th, from 2-4 pm, the “48th Annual WRHS Foundation Perennial Plant Sale” will be held at the West River Ambulance Garage (located at 307 Adams Avenue, Highway 12, across the street from the Kum N Go). You might want to be there right at 2:00 pm sharp, as last year most all of the perennials were gone by 3:15! For a goodwill donation, you can purchase perennial plants, and the good feeling that 100% of your gift is going toward a local

area student pursuing a healthcare degree, via our “Auxiliary Legacy Scholarship.” And remember, you can deliver your overgrown perennials to the Ambulance Garage before the sale (Thursday all day or Friday morning prior to the sale at 2pm) -- to pay them forward! Not only will you be allowing someone else to replant them, but also the WRHS Foundation will receive goodwill donations for the perennials, which will then be paid forward for local student’s academic scholarships.

The West River Health Services Auxiliary, which began seventy-five years ago in 1950 with the new Community Memorial Hospital in Hettinger, started with a group of local volunteers, who helped raise funds for needed healthcare amenities. Eventually the WRHS Auxiliary raised more funds for improvements to the hospital/clinics, plus scholarships for local area students. One of their annual fundraisers, for 48 years now, was the Annual “Perennial Plant Sale.”

Since the WRHS Auxiliary disbanded six years ago, it was hoped that the WRHS Foundation would take on the Auxiliary’s “Perennial Plant Sale.” With the help of longtime volunteers and employees, and former Auxiliary Member

leaders, Barb West and Jennifer Seamands, we held our 47th Perennial Plant Sale last year, raising over \$2,000 for our Auxiliary Legacy Academic Scholarship Fund. A local area student (Reagan Coyle from Bowman High School), who is pursuing a Sonography degree at Bismarck State), was the beneficiary of the perennial sale fundraiser.

Therefore, we need local gardeners to consider thinning out their perennial flower beds and gifting them to our WRHS Perennial Plant Sale. Barb West (701-567-2736) and Jennifer Seamands (701-567-4650) are available via telephone if you have any questions about the sale. Just bring your excess perennials Thursday all day or Friday morning to the

West River Ambulance Garage. Then return at 2pm on Friday, May 16th, to select whatever you’d like to add to your flower bed. Plus, bring your checkbook or a little cash that you’d like to offer for a freewill donation (some years, we’ve received small trees, annuals and vegetables. Strawberry plants, rhubarb and raspberry plants are top sellers).

Thank you for considering thinning down your perennials in your garden and making a donation to our 48th Annual WRHS Foundation Perennial Plant Sale on May 16th. Plus, thank you for attending and possibly making a goodwill donation toward our Auxiliary Legacy Scholarship. We always need more sensational care givers here. Onward!
