Storm slams Grant County with hurricane-force winds

Derecho causes widespread damage across region

What began as a picture-perfect summer day in Grant County quickly turned into a night to remember, and one many residents won't soon forget.

Friday's sunshine and mid-80s temperatures made for ideal conditions as crowds flocked to the area for the annual Highway 21 Rummage Sale and the kickoff of the Elgin Celebration and All-School Reunion. But as the evening approached, a predicted weather system intensified into a powerful and fast-moving derecho, slamming into Grant County around 7:15 p.m. with winds topping 90 miles per hour in some locations.

Members of the Elgin Celebration Committee had been watching the skies and weather reports closely throughout the day. Volunteer firefighter and committee member Brian Richardson was in regular contact with the National Weather Service to monitor any threats to public safety. "With so many people in town — including those staying in campers — we wanted to be as prepared as possible," Richardson said. "Our goal was to keep everyone safe."

As evening activities got underway including hamburgers in the park, bingo in the community

center, and a lively corn-hole tournament along Main Street, the weather took a dramatic turn. Dark clouds rolled in, and the winds followed with a vengeance.

In Leith, wind speeds were clocked at 71 mph. North of New Leipzig saw gusts of 94 mph, Lark hit 88 mph, and Mott recorded 92 mph. Prairie Knights Casino reported gusts of 68 mph. Residents scrambled for cover, seeking shelter in open buildings or designated storm shelters like the one located on Elgin's south side.

Lake Tschida bore the brunt of the storm, where damage was extensive. Boats and docks were battered, trees were torn from the ground, and a camper was flipped onto its side along Highway 49 near the Heart Butte Dam. Elsewhere in the county, grain bins were crumpled, trees snapped like twigs, sheds shifted off foundations, quonset doors were ripped away, and hopper bins were knocked over.

The storm caused 982 power outages across Grant County, with damage reported to both distribution and transmission lines. While some residents saw power restored within minutes, others waited up to 48 hours. Teams from Mor-Gran-Sou Electric Cooperative and Montana Dakota Utilities worked tirelessly through the weekend to bring power back online.

Jared Fischer, Grant County Emergency Coordinator, praised the community's swift response: "It's amazing how the community came together — cleaning up and checking on each other. It shows that we are a very resilient people, and we take care of each other."

City of Elgin Maintenance Engineer Wayne Iszler, along with members of the Elgin Celebration Committee, Elgin Fire Department, among others were up early Saturday morning clearing debris and fallen trees to ensure roads and walkways were safe for continued weekend events.

The National Weather Service officially classified the event as a derecho - a long-lived, violent windstorm characterized by a band of rapidly moving storms. After tearing through western North Dakota, the storm system pushed eastward, producing 13 confirmed tornadoes, destroying homes, and tragically claiming three lives.

Despite the damage, community members are focused on recovery and grateful that no local injuries have been reported. For many in Grant County, the storm was a sobering reminder of nature's power — and the strength that comes from facing it together.
