Little Blue Jay Nest set to provide child care services starting Aug. 18

Career and Technology Center's new child care center is officially licensed and will begin providing services on

"It's been a process to get there but it's pretty exciting," said Teresa Olson, coordinator for the Little Blue Jays Nest and family and consumer science teacher. The hours for the Little Blue Jay Nest will follow the regu-

lar school schedule from

7:30 a.m. to 4:30 p.m. The Little Blue Jay Nest is accepting applications for children of employees of the James Valley Career and Technology Center's schools and partners — Jamestown Public Schools, Montpelier Public Schools, Pingree-Buchannon Public Schools, Gackle Public Schools, James River Special Education Unit and the University of Jamestown. The child care center also has a limited number of spots

The James Valley Career and Technology Center operates the child care facility which has been licensed by the North Dakota Department of Health and Human Service Department's Early Childhood Licensing Unit. The Little Blue Jay Nest is licensed for 65 children, Olson

for the community.

"Our goal is we don't ever want to hit that much because we want to make sure that we provide the care with a lot of quality," said Heidi Eckart, assistant director of the James Valley Career and Technology Center. "We have enough space that they license us for more, but our goal is to stay wnere we make sure the kids get that one on one, kids are getting a lot of that independent skills to build independence but also lots of nurturing."

Olson said a committee worked with Verla Jung, start-up and community engagement coordinator at Child Care Aware of North Dakota, who helped guide the committee through the process of getting a child care license.

Olson said the committee prepared handbooks and submitted all the requirements the state needs to license a child care facility.

"As a new center, you have to have background

checks for everybody, which there's a new provider orientation that has to be completed," she said. "We have to make sure you get all of your documents together for inspections for the building. So there's several components that get put together that all get submitted before they even come out to look at your place. Then once the licensor comes out, she walks through and asks some questions, make sure we are hitting the standards that the state has.'

Jamestown Public School District staff with children in the Little Blue Jay Nest qualify for the Working Parents Child Care Relief Program, said Adam Gehlhar, director of the Career and Technology Center, in an email to The Jamestown Sun. For the program, the employer provides a monthly child care paid benefit and opts in for a state match of \$300.

"That's per employee, so not per child," Eckart said. "So if you had somebody in the district that both parents were working, they both can take that out. So that would be a huge savings for those that are in those situations."

She said the Little Blue Jay Nest's goal was to help with a need in the community.

"That was never our intention was to make a profit off of it," she said. "It's to offer a service and be able to sustain it.

In 2024, the Jamestown Public School Board approved a proposal to add child care programming and services at the Career and Technology

The renovation of the child care center at the Career and Technology Center was completed using funds from a \$500,000 Regional Workforce Impact Program

The renovation included turning space used for aviation and construction into a child care facility. The child care facility is located on the south side of the Career and Technology Center.

The aviation and construction classrooms were moved to different locations at the Career and Technology Center.

Olson said the rooms for the Little Blue Jay Nest include new cribs, cots, tables, chairs, shelves and toys. An outdoor playground is also planned.

The dropoff and pickup

area for the children will be on the south side of the Career and Technology Center.

Olson said students in Career and Technology Center programs helped with the renovation.

"We've had our construction tech kids in there helping," she said. "Our autobody kids helped do some painting in there for the radiators. Our welding precision machine kids helped get some of the desks to kind of set up."

The Little Blue Jay Nest is completely different than the play school that students learn to operate and manage.

"We will still have that where our students still have that experience," Olson said.

The Little Blue Jay Nest has four staff members with more than 85 years of experience in education and child care

"We've got some phenomenal staff with great years of experience,' Eckart said.

Olson said students who have completed the child development class, child care block class and have lab experience can do work-based learning at the Little Blue Jay Nest. She said those students would not be counted as staff members but as volunteers helping out.

'So we'll meet our ratios with our staffing, and then they'll just be extra attention and care and opportunities for the little ones as well as the high school kids," she

A parent meeting is at noon with refreshments with a public open house to follow.

Olson said staff and students are trained in providing CPR, first aid and using an automated external defibrillator for infants and pediatrics. She said they also have to complete training to be a mandated reporter and for safe sleep.

"There's always continuing ed that happens," she said. " ... It's a state mandated requirement but it also keeps you current, and if there's new things coming up to try to provide the best care we can for kids because there's always new ideas that we don't think of that others do."

Olson said the school district will prepare breakfast and lunch for the children in the Little Blue Jay Nest while child care staff provide morning and afternoon snacks.


