The proposed amendment is summarized as follows: constitutional amendments would be limited to one subject. The Secretary of State shall not approve an initiative petition for circulation if the Secretary determines that the proposed amendment comprises more than one subject. Additionally, the legislative assembly is required to limit proposed amendments to the constitution to one subject. The estimated fiscal impact of this measure is none.
